1 INTRODUCTION

- 1.1 I was appointed as liquidator of Alomega Designs Limited by the Secretary of State on 11 November 2013. I am licensed in the UK by the Institute of Chartered Accountants in England and Wales. I confirm that there has been no change in office-holder since the date of my appointment.
- 1.2 This report has been prepared in accordance with the requirements of Rule 4 49B of the Insolvency Rules 1986 (as amended) to provide creditors with a report on the progress of the liquidation
- Much of the information contained in this report encompasses the whole period of the liquidation Please be aware however, that where reference is made to "the period of this report, this specifically means 11 November 2015 to 10 November 2016 being the period of 12 months to the most recent anniversary of my appointment

2 CONDUCT OF THE LIQUIDATION

2.1 Antecedent transactions

No antecedent transactions have been identified by the Liquidator which can be pursued

Accordingly no further action is to be taken

The sum of £1,000 plus VAT was provided by the petitioning creditor, Claymore Consultancy to fund the investigations

2.2 Lease

The Director has advised that there was no tenancy agreement between him and the Company in respect of the trading premises 47 Lawrence Road, London, N15 4EN

Accordingly no further action is to taken

2 3 Debtors & Stock

The last filed accounts for the year ended December 2009 show assets of stock in the sum of £35,033 and debtors in the sum of £12,902

No further action to be taken given the limited information and the length of time which has elapsed since the accounts were filed and the date of the winding up Order and the litigation risk in pursuing this matter

The Director has advised that the Company did not have any assets

No other assets have been identified in this matter

APPENDIX C

ADDITIONAL INFORMATION IN RELATION TO THE POLICY OF LEONARD CURTIS REGARDING FEES AND DISBURSEMENTS

The following information relating to the policy of Leonard Curtis is considered to be relevant to creditors

Staff Allocation and Support Staff

We take an objective and practical approach to each assignment which includes active director involvement from the outset. Other members of staff will be assigned on the basis of experience and specific skills to match the needs of the case. Time spent by secretarial and other support staff on specific case related matters, e.g. report despatching, is not charged. Where it has been agreed by resolution of the secured creditors, a creditors' committee or creditors generally, that the office holders' remuneration will be calculated by reference to the time properly given by the office holders and their staff in attending to matters ansing in the appointment, then such remuneration will be calculated in units of 6 minutes at the standard hourly rates given below. In cases of exceptional complexity or risk, the insolvency practitioner reserves the right to obtain authority from the appropriate body of creditors that their remuneration on such time shall be charged at the higher complex rate given below. With effect from 6 January 2014 the following hourly charge out rates apply to all assignments undertaken by Leonard Curtis.

Subcontractors

Details and the cost of any work which has been or is intended to be sub-contracted out that could otherwise be carried out by the office holders or their staff will be provided in any report which incorporates a request for approval of the basis upon which remuneration may be charged

Professional Advisors

Details of any professional advisor(s) used will be given in reports to creditors. Unless otherwise indicated the fee arrangement for each is based on hourly charge out rates, which are reviewed on a regular basis, together with the recovery of relevant disbursements. The choice of professional advisors is based around a number of factors including, but not restricted to, their expertise in a particular field, the complexity or otherwise of the assignment and their geographic location.

Disbursements

- a) Category 1 disbursements. These are costs where there is specific expenditure directly referable both to the appointment in question and a payment to an independent third party. These may include, for example, advertising, room hire, storage, postage, telephone charges, travel expenses, and equivalent costs reimbursed to the office holder or his or her staff. Category 1 disbursements may be drawn without prior approval.
- b) Category 2 disbursements. These are costs that are directly referable to the appointment in question but not to a payment to an independent third party. They may include shared or allocated costs that can be allocated to the appointment on a proper and reasonable basis, for example, business mileage.
