1 ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

Turnover

Turnover comprises the value of food and drink consumed by customers excluding value added tax

Goodwill

Purchased goodwill is written off over 15 years being its estimated economic life

Tangible fixed assets

Tangible fixed assets are started at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of the assets, less their estimated residual value, over their expected useful lives at the following annual rates

Leasehold property - over the period of the lease
Fixture, fittings and equipment - 15% reducing balance basis
Motor Vehicle - 25% reducing balance basis
Tenants capital outlay - over the period of the lease

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date

Going concern
