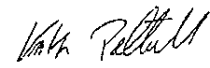

2. PROGRESS DURING THE PERIOD & MATTERS OUTSTANDING

Attached at Appendix 1 is my abstract of receipts and payments for the period from 5 June 2014 to 19 July 2014.

The Administrator set out to achieve the following objectives:

- Rescue the company as a going concern or if not achievable
- Achieve a better result for the company's creditors as a whole than would be likely if the company were wound up without being first being in administration or
- Realise the company's assets in order to make a distribution to one or more secured or preferential creditors

The Administrator still considers objective (b) above to be achievable.

Further to my last progress report, I can advise of the following:

Directors Loan Account

This remains under investigation.

Deferred Consideration

As advised in our previous progress report dated 4 June 2014, the Company is potentially entitled to deferred consideration arising from the asset sale agreement to The Mobility Rental Group Limited on 24 February 2012. This deferred consideration is due to be a sum equal to 10 percent of the tax saved by the purchaser as a result of the utilisation of any tax losses deemed available for transfer and use by the purchaser.

Until such time as the purchaser is able to demonstrate use of these transferred tax losses to relieve against future profits, the Joint Administrators will not be in a position to determine whether any additional funds will be due from The Mobility Rental Group Limited by way of the deferred consideration.

3. REMUNERATION

The Administrator's remuneration is based on hourly costs at scale rates calculated on the time properly spent in the course of the administration

Total time spent for the period from 5 June 2014 to 19 July 2014 on this assignment amounts to 10 20 hours at an average rate of £198 19 per hour resulting in total time costs for the period of £2,021 50 excluding VAT and outlays of £28 74, excluding VAT

4. CREDITORS CLAIMS

It appears unlikely at this stage of the administration that there will be sufficient funds available to pay a dividend to preferential or unsecured creditors

5. OTHER RELEVANT INFORMATION

The Administrator has completed his investigation into the general affairs of the company to determine its property and liabilities and to identify any actions that could lead to the recovery of funds prior to this period. In addition, the Administrator also completed his report to the Department of Trade & Industry on the conduct of the company directors

6. CONCLUSION

The period of administration has been extended by order of the Court to 19 July 2015
