2. Structure, Governance and Management

Governing Document

Association of Ghanaian Ex-Servicemen & Women UK Ltd is a charitable company limited by guarantee, having been incorporated on 23 November 2004 and is governed by its Memorandum and Articles of Association. The company was registered as a charity on 4 April 2005. The organisation started in August 2004 as a voluntary community group supporting the welfare, social, health and education needs of Ghanaian ex-servicemen and women living in the United Kingdom.

Today, the charity works across the UK to support ex-servicemen and women from Ghana, West Africa and other minority ethnic communities Majority of these are migrants, asylum seekers and refugees

Appointment and induction of Trustees

The Trustees of the charity, who are also Directors of the Company, are elected at the Annual General Meeting or co-opted by the Directors

Newly elected or appointed trustees are provided with a comprehensive induction pack containing the Association's Memorandum and Articles of Association and the roles and responsibilities of charity trustees and mentoring by established trustees

Organisational Structure

Association of Ghanaian Ex-Servicemen and Women UK Ltd is governed by its Executive Committee which is responsible for setting strategic direction and policies of the charity. The Executive Committee carry out the ultimate responsibility for the conduct of the Association and ensuring that the charity satisfies its legal and contractual obligations. Trustees meet once in every two months to take decisions for the smooth running of the organisation. A register of members is maintained at the registered office and is available to the public

Major risks

Trustees recognise that any major risks to which the charity is exposed need to be reviewed and systems put in place to mitigate those risks. To that end, the Association is continually monitoring and managing its risk, reviewing the corporate risk register and ensuring action plans are in place to mitigate its key risks.

Included in external risks is that of loss or lack of funding. At present, the main sources of funding are dues and levies imposed on members, fundraising activities and voluntary donations by the general public and other voluntary associations. The charity continues to seek to diversify its funding sources and would soon be applying to charitable trusts and statutory funders.

Internal risks are minimised by the implementation of procedures for authorisation of all transactions and projects to ensure consistent quality of delivery for all operational aspects of the charitable company. These procedures are periodically reviewed to ensure that they still meet the needs of the charity

3. Objectives and Activities

The Objects of the Charity as stated in its Memorandum and Articles of Association are

- 1 To relieve poverty and distress, preserve and protect good health and advance the education of Ghanaian refugees, particularly but not exclusively those who have served in the Ghana Armed Forces and their dependants, who are now based in the UK, by the provision of financial assistance in such matters as health, education, training for employment, translation of services, welfare rights and such other services as the trustees deem necessary with the object of improving the conditions of life to such persons
- 2 The provision of facilities for recreation and leisure-time occupation in the interest of social welfare with the object of improving the conditions of life for those persons who have need of such facilities

In view of the above, the Association of Ghanaian Ex-Service & Women UK Ltd carried out the following activities during the period

Social Activities:

Social activities aim to provide avenues for entertainment to wind down and to relieve the effects of stressful living in the UK. A significant proportion of the membership is of old age pensioners who have a number of social, medical and financial challenges and are living alone and vulnerable. We organised mother's day, WASSA activities, fun days and family times together to relieve isolation of many families.

We also involved members of Association of Ghanaian Ex-Servicemen & Women UK Ltd in various social gathering and activities in the year which were highly patronised by both young and old people. Our social activities during the August, Easter and Christmas holidays brought many families, children, young and old people together to interact and entertain themselves.

Welfare Activities

Association of Ghanaian Ex-Servicemen & Women UK Ltd started as a welfare organisation Our welfare activities in the period involved support for members and non-members in London in moral and financial terms during times of bereavement and sickness

Community Development

In the period under review, the charity extended its charitable arms to other voluntary and community organisations in London by supporting their fundraising activities and development meetings including dinner dances, festivals and family days. We provided financial support totalling £200 to two of these affiliated organisations in the year

Review of Work

Association of Ghanaian Ex-Servicemen & Women UK Ltd is always reviewing its work, policies, procedures and support to benefit users. These reviews are aimed purposely at improving quality of life for services users. Directors would like to see more members actively involved in community meetings, social activities and celebrations

Members have realised that the monthly meetings have strengthened their confidence to come out and take part in activities to benefit the community. The meetings have also provided opportunity for members to help one another in times of difficulty

Directors have identified the need in the year, for members of the association to benefit from Gift Aid The directors would like to encourage members to complete Gift Aid forms when donating to the good work of the Association It is our belief that when more members understand this process, they will increase their commitment to the association and the community, and get involve in more activities to support one another

5. **Future Plans**

In the period under review, the Association focused on providing financial and emotional support to members and disadvantaged families in need Directors would like to take this support forward by organising six monthly meetings in the year for the community to come together and interact more and get to know one another Trustees believe this interaction will sustain the interest, involvement and participation of members in the charity's activities

In the coming years, the Executive Committee will focus strongly on important decisions taken in the year including partnership working with sister organisations in the UK Directors would also like more support in the form of counselling and financial support to those who lose their parents and loved ones

The Directors extend their gratitude to members of the charity who are at present the main source of funding for its activities

1. Accounting Policies

•

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the period.

a) Basis of Preparation

The financial statements have been prepared under the historical cost convention in accordance with the Companies Act 1985, applicable accounting standards and the Statement of Recommended Practice (SORP) Accounting and Reporting by Charities, issued in March 2005

b) Company Status

The Charity is a company limited by guarantee The members of the company are the directors who are also ordinary members of the charity and named on page 1 In the event of the Charity being wound up, the liability in respect of the guarantee is limited to £1 per member of the company

c) Fund Accounting

Unrestricted Funds comprise accumulated surpluses and deficits on general funds that are available for use at the discretion of the trustees in furtherance of the Charity's objects and that have not been designated for other purposes

Restricted Funds are funds subject to restrictions on their expenditure imposed by the donor or through the terms of an appeal

d) Incoming Resources

Recognition of Incoming Resources

These are included in the Statement of Financial Activities when

- the charity becomes entitled to the resources,
- the trustees are virtually certain they will receive the resources, and
- the monetary value can be measured with sufficient reliability

Membership dues are recognised when received

e) Resources Expended

Recognition of Expenditure and Liabilities

Liabilities are recognised as soon as there is a legal or constructive obligation committing the charity to pay out resources

Expenditure is recognised on an accruals basis as a liability is incurred

f) Costs of Charitable Activities

These comprise those costs incurred by the charity in the delivery of its activities and services. They include both costs that can be directly allocated to the charity's activities and costs of an indirect nature necessary to support these activities.

g) Governance Costs

Ą

These are the costs associated with the governance arrangements of the charity. They include the costs of the preparation and examination of statutory accounts, trustees meetings and the costs of any legal advice given to trustees on governance or constitutional matters.

All costs are charged between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource. Costs relating to a particular activity (or project) are allocated directly, others are apportioned on an appropriate basis

h) Fixed Assets

Tangible Fixed Assets for charity's own use

These are capitalised if they can be used for more than one period, and cost at least £250. They are valued at cost or, if gifted, at the value to the charity on receipt

i) Depreciation

Tangible Fixed Assets are depreciated so as to write off their cost less any estimated residual value over their useful lives at the following rates
