 - (c) conditional upon the subdivisions of the existing ordinary shares outlined at (a) and (b) above the 22,256,422,122 new ordinary shares of £0 0000005 each be consolidated into 222,564,221 ordinary shares of £0 00005 each, such shares having the same rights and being subject to the same restrictions (save as to nominal value) as the existing ordinary
