





ORDER

UPON reading the Application dated 16 May 2011 for a block transfer Order ("the Application")

UPON reading the Witness Statements of Lynn Robert Bailey ("the Applicant") dated 16 May 2011 and Guy Edward Brooke Mander dated 16 May 2011 and the exhibits thereto

AND THE COURT determining to dispose of the application without a hearing

IT IS ORDERED THAT -

- 1 Service of the application upon any person is dispensed with

- 2 The relevant proceedings referred to in the Schedule to the Witness Statement of the Applicant, a copy of which is annexed to this Order ("the Schedule"), be transferred to the High Court of Justice, Chancery Division, Birmingham District Registry for the purposes of this

Application pursuant to Rule 7 11(4) and (4A) of the Insolvency Rules 1986

- 3 Pursuant to Section 19 and Paragraph 88 of Schedule B1 Insolvency Act 1986 and Rule 7 10B(2) Insolvency Rules 1986, the Applicant be removed from office as Administrator of each of the companies identified in the Schedule as being in administration
- 4 Pursuant to Section 108 Insolvency Act 1986, the Applicant be removed from office as Liquidator of each of the companies identified in the Schedule as being in voluntary liquidation
- 5 Pursuant to Section 7(5) and Paragraph 39(6) of Schedule A1 Insolvency Act 1986, the Applicant be removed from office as Supervisor of each of the company voluntary arrangements identified in the Schedule
- 6 Pursuant to Section 172(2) Insolvency Act 1986 and Rule 7 10B(2) Insolvency Rules 1986, the Applicant be removed from office as Liquidator of each of the companies identified in the Schedule as being in Compulsory Liquidation
- 7 The individuals identified as New Appointees in the Schedule, all being Licensed Insolvency Practitioners, be appointed the new Liquidator, Administrator or Supervisor of the relevant Estates, identified in the Schedule in place of the Applicant and in each case with immediate effect
- 8 The Witness Statement of the Applicant dated 16 May 2011 and the letters from the specified New Appointees exhibited to the witness statement of Guy Edward Brooke Mander dated 16 May 2011 do stand as the relevant statements for the purposes of Rule 4 103 of the Insolvency Rules 1986
- 9 Each of the individuals identified as a New Appointee in the Schedule, shall, within 28 days of the date of this Order serve notice of the removal of the Applicant and his or her appointment in place of the

Applicant, on the creditors of each Estate by advertising the same in (a) The London Gazette and (b) one local newspaper, covering, insofar as reasonably possible, the area in which the insolvency is based, such notice to be in the same or substantially the same form as the draft Advertisements annexed to this Order

- 10 Any creditor who is affected by this Order shall have permission to apply to the Birmingham District Registry of the Chancery Division of the High Court within 28 days of receiving notice of it -
- 10 1 To vary or discharge this Order, and
- 10 2 In the case of any liquidations, for an Order that the Applicant should arrange for the preparation and provision to them of a summary of his receipts and payments and a statement that he has reconciled his account with that which is held by the Secretary of State
- 11 The Applicant be at liberty to apply to this Court in relation to obtaining her release in respect of the insolvency matters listed in the Schedule
- 12 The costs of this Application and compliance with it are provided for as follows -
- 12 1 Such remuneration, costs or expenses in respect of this Application as are referable to any particular matter in the Schedule shall be fixed and paid in the ordinary way as remuneration, costs or expenses in respect of such matters,
- 12 2 Such costs or expenses in respect of this Application as are not referable to a particular matter shall be divided equally between the various Estates in the Schedule and thereafter treated as costs or expenses of such matters,
- 12 3 Provided that in no circumstances shall the costs payable pursuant to this Order in relation to a particular Estate, exceed 10% of the value of the realised assets in that Estate
