# DIRECTORS' & TRUSTEES' REPORT for the year ended 31 March 2014

### **Aims**

Friends of Nidderdale AONB aims are as follows:

- 1. To promote, enhance and conserve the physical and natural environment and its natural beauty for the public benefit within the Nidderdale Area of Outstanding Natural Beauty (Nidderdale AONB)
- 2. To advance the knowledge and understanding of the public in the physical and natural environment including but not limited to the management of natural resources and local economic development that is environmentally sustainable

#### Governance

Friends of Nidderdale Area of Outstanding Natural Beauty is a Charitable Company limited by guarantee and without share capital.

All of the Directors of the company are Trustees and Members.

Trustees are appointed by a vote at a meeting of Directors/Trustees according to their willingness to contribute effectively to the Company's aims working harmoniously within the corporate team.

During the year, and following legal advice, the Trustees updated the Articles of the Company to reflect the Companies Act 2006.

## Friends and Firm Friends membership

All new individual and family subscribers pay an annual minimum donation of £15 individual, £20 double and £25 family in order to receive their membership benefits. However, recognising their loyalty to the organisation, existing individual member subscriptions remain at £10 per annum. Trustees and other volunteers who are registered as such by the AONB are entitled to free membership of Friends.

Regarding Firm Friends, our business membership scheme, the England Rural Development Program (ERDP) funded Leader project has reached a successful conclusion. The business membership scheme is based on Corporate Social Responsibility and it will be continued with the help of a consultant for a transitional year after which the project will be managed by Trustees.

At 31 March 2014 22 businesses were members and we continue to attract new business members.

### **Finance**

Income from donations, Firm Friends' Subscriptions and bank interest totalled £11,691. A reclaim for Gift Aid on donations is calculated to return approximately £500. We have also accessed funding of £3,661 for small Hydro Schemes and Tree Planting.

### Reserves

The Company does not have a policy of accumulating reserves and expects to distribute its funds according to its aims. However, funds will be accumulated from time to time so that larger projects can be supported.

### Communication

During the year, we had good press coverage and we produced a Newsletter for subscribers and Firm Friends. The Annual Meeting of Friends was held on 10 June 2013.

## **Direction and Strategy**

As was flagged in last year's annual report, it was the Trustees intention to work more closely with the AONB to help it to achieve its business plan in a period of reduced public funding. For instance, the AONB found it could no longer run a small grants scheme. In order to fill this gap Trustees have agreed to set up a *Countryside Fund* to attract donations and from which it they will provide grants of up to £2,000 to support landscape, heritage and educational projects within the AONB. The *Countryside Fund* became operational in the Summer of 2014.

As a registered charity, Friends is able to apply for funding which publicly funded bodies, including the AONB, are not eligible. Trustees will actively pursue such opportunities whenever possible.

The AONB has been successful in obtaining Heritage Lottery Funding for an Upper Nidderdale Landscape Partnership Scheme and for a WW1 Commemoration Scheme. As a partner organisation the Trustees have committed match funding to both these schemes and over the next few years we will work closely with the AONB towards their successful completion.

- Organising Rotary Tree planting days
- · As volunteers in many other capacities

# **Projects supported**

Support for small hydro schemes is ongoing. In addition, support has been given to tree planting, Bio Blitz Day and the AONB's Volunteer Programme.

As mentioned above, since the year end the Trustees have created a *Countryside Fund* to provide grants up to £2,000. At the date of this report several projects have already been supported and others applications are under consideration. More detail will be provided in the Trustees' Report for the year ending 31 March 2015.

# **Directors' Meetings**

The Directors of the company met in committee on six occasions during the year ended 31 March 2014:

20 May 2013, 1 July 2013, 2 September 2013, 4 November 2013, 6 January 2014 and 3 March 2014.

In addition, the Directors held a number of meetings to discuss future strategy and plans.

### **Public Benefit**

In planning their activities for the year the Trustees confirm that they have considered the Charity Commission's guidance on Public Benefit and believe that all of their activities (as summarised in this Report) fulfil the requirement to provide Public Benefit.

### **Future Plans**

The Friends is currently in a period of development and realignment. Over the next year it will continue to build capacity by continuing with its:

- Recruitment Campaign of Friends and Firm Friends (including updating recruitment literature)
- Fundraising Campaign
- Publicity Campaign
- Complete its review of publicity material and administrative processes

### 1) Accounting Policies:

The principal accounting policies are summarised below.

### a) Accounting convention

The Financial Statements have been prepared under the historical cost convention and in accordance with applicable accounting standards (UK Generally Accepted Accounting Practice). In preparing the financial statements the charity follows best practice as laid down in the Statement of Recommended Practice 'Accounting and Reporting by Charities' (SORP 2005).

### b) Income

Income is recognised in the period to which it relates.

There is no recognition of the financial value of pledges freely contributed by Friends.

### c) Expenditure

All expenditure is recognised on an accruals basis, inclusive of VAT.

### d) Cash flow statement

The company has taken advantage of the exemption available under FRS 1 'Cash Flow Statements' not to present a Cash Flow Statement.

### 2) Income and Expenditure Account:

All recognised gains and losses are reflected in the Income and Expenditure Account, and no separate Statement of Total Recognised Gains and Losses is presented.

### 3) Share Capital:

The company is a charitable company limited by guarantee and therefore has no share capital. In the event of the company being wound up, the maximum amount which each member is liable to contribute is limited to a guarantee of £10.

# 4) Capital commitments:

There were no capital commitments at 31 March 2014 (2013: Nil).

### 5) Taxation:

HM Revenue & Customs have accepted that the company's income and gains are either exempt from tax or have been, or will be, applied for charitable purposes only, and accordingly no taxation is payable.
