## Parties

- (1) **GEB SURFACE TREATMENTS LIMITED**, a company incorporated and registered in England and Wales with company number: 05419979 whose registered office is at Nasmyth House Coventry Road, Exhall, Coventry, England, CV7 9FT (the **Chargor**); and
- (2) **JCP FIVE LIMITED**, a company incorporated and registered in England and Wales with company number: 12565127 whose registered office is at 5th Floor 24 Old Bond Street, London, United Kingdom, W1S 4AW (**Creditor**).

## Agreed terms

### 1 Definitions and interpretation

#### 1.1 Definitions

The definitions and rules of interpretation in this clause apply in this debenture.

**Accession Deed:** shall have the meaning given to that term in the Loan Agreement and the term **Accession Deeds** shall mean all of them

**Additional Security:** shall have the meaning given to that term in the Loan Agreement.

**Administrator:** an administrator appointed to manage the affairs, business and property of the Chargor pursuant to paragraph 15 of Schedule 5.

**Book Debts:** all present and future book and other debts and monetary claims due or owing to the Chargor, and the benefit of all security, guarantees and other rights of any nature enjoyed or held by the Chargor in relation to any of them (to the extent not assigned or charged to STB under the STB Loan Documents or STB Security Documents).

**Business Day:** a day (other than a Saturday or Sunday) on which commercial banks are open for general business in London and deposits are dealt with on the London Interbank Market.

**Charged Property:** all the assets, property and undertaking for the time being subject to the security interests created by this debenture (and references to the Charged Property shall include references to any part of it).

**Costs:** all costs, charges, expenses and liabilities of any kind including, without limitation, costs and damages in connection with litigation, professional fees, disbursements and any value added tax charged on such costs and the Creditor's internal costs including, without limitation, management time and expenses and in-house legal counsel time and expenses.

**Deed of Priority:** shall have the meaning given to that term in the Loan Agreement.

**Designated Account:** any account nominated by the Creditor as a designated account for the purposes of this debenture.

**Drawdown Request:** shall have the meaning given to that term in the Loan Agreement.

**Encumbrance:** any mortgage, charge (whether fixed or floating, legal or equitable), pledge, lien, assignment by way of security or other security interest securing any obligation of any person, or any other agreement or arrangement having a similar effect.

**Enforcement Event:** any of the events listed in paragraph 1 of Schedule 5.

**Environment:** the natural and man-made environment including all or any of the following media, namely air, water and land, including (without limitation) the air within buildings and other natural or man-made structures above or below ground, ground and surface water, surface and sub-surface soil and living organisms (including man) or systems supported by those media.

**Environmental Law:** all applicable statutes, treaties, regulations, secondary legislation, bye laws, common law, directives or similar measures relating to the pollution or protection of the Environment that affects the Charged Property.

**Equipment:** all present and future equipment, plant, machinery, tools, vehicles, furniture, fittings, installations and apparatus and other tangible moveable property for the time being owned by the Chargor, including any part of it and all spare parts, replacements, modifications and additions.

**Excluded Property:** each leasehold property held by the Chargor under a lease that either precludes absolutely, or requires consent of a third party to, the creation of any Encumbrance over the Chargor's leasehold interest in that property.

**Financial Collateral:** shall have the meaning given to that expression in the Financial Collateral Regulations.

**Financial Collateral Regulations:** the Financial Collateral Arrangements (No. 2) Regulations 2003 (*SI 2003/3226*).

**Financing Documents:** the Loan Agreement, the Guarantee, the Group Debenture, this debenture, all debentures entered into by the Chargor or an Obligor in favour of the Creditor, all guarantees entered into by the Chargor or an Obligor in favour of the Creditor, the Deed of Priority, the Subordination Deed, all Accession Deeds, all Drawdown Requests, all Additional Security and any document pursuant to any of them or any document relating to any of the Secured Liabilities and any other document designated as such in writing by the Creditor from time to time, and the term **Financing Document** shall mean any of them.

**Group Debenture:** shall have the meaning given to the term "Debenture" in the Loan Agreement.

**Guarantee:** shall have the meaning given to that term in the Loan Agreement.

**Insurance Policies:** the insurance policies referred to in clause 3.1.3.

**Intellectual Property:** the Chargor's present and future patents, trade marks, service marks, trade names, designs, copyrights, inventions, topographical or similar rights, confidential information and know-how and any interest in any of these rights, whether or not registered, including all applications and rights to apply for registration and all fees, royalties and other rights derived from, or incidental to, these rights.

**Investments:** all present and future stocks, shares, loan capital, securities, bonds and investments (whether or not marketable) for the time being owned (at law or in equity) by the Chargor, including all rights accruing or incidental to those investments from time to time.

**Loan Agreement:** the secured working capital loan agreement entered into between the Creditor (as lender), Nasmyth Enterprises Limited (as original borrower), the Chargor and other Obligors (as original obligors) dated 21 February 2022.

**Obligors:** shall have the meaning given to that term in the Loan Agreement and such persons who become guarantors and/or obligors under the terms of any Financing Document, and the term **Obligor** shall mean any of them.

**Properties:** all freehold and leasehold properties wherever situate (whether registered or unregistered) and all commonhold properties, now or in the future (and from time to time) owned by the Chargor, or in which the Chargor holds an interest including, without limitation, the Properties listed at Schedule 1 and **Property** means any of them.

**Receiver:** a receiver and/or manager of any or all of the Charged Property appointed under paragraph 6 of Schedule 5.



**Secured Liabilities:** all present and future monies, obligations and liabilities of any kind and in any currency owed or incurred by each Obligor to the Creditor, whether present or future, actual or contingent and whether owed jointly or severally, as principal or otherwise together with all interest (including, without limitation, default interest) accruing in respect of such monies or liabilities, all of the **Creditor's costs, charges**, commission and expenses.

**Security Financial Collateral Arrangement:** shall have the meaning given to that expression in the Financial Collateral Regulations.

**Security Period:** the period starting on the date of this debenture and ending on the date on which all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full and no further Secured Liabilities are capable of being outstanding.

**STB:** shall have the meaning given to that term in the Loan Agreement.

**STB Loan Documents:** shall have the meaning given to that term in the Loan Agreement.

**STB Security Documents:** shall have the meaning given to that term in the Loan Agreement.

**Subordination Deed:** shall have the meaning given to that term in the Loan Agreement.

**US Receivables:** all present and future intercompany receivables or other debts due to the Chargar from any of the US Subsidiaries.

**US Subsidiaries:** each of Nasmyth Aerospace Holdings, Inc., Nasmyth Industrial Holdings, Inc., Nasmyth Holdings, Inc., Nasmyth Precision Products, Inc., Nasmyth TMF, Inc.

## 1.2 Interpretation

Unless the context otherwise requires, in this debenture:

- 1.2.1 a reference to a statute or statutory provision includes a reference to any subordinate legislation made under that statute or statutory provision, to any modification, re-enactment or extension of that statute or statutory provision and to any former statute or statutory provision which it consolidated or re-enacted before the date of this debenture;
- 1.2.2 a reference to one gender includes a reference to the other genders;
- 1.2.3 words in the singular include the plural and in the plural include the singular;
- 1.2.4 a reference to a clause or Schedule is to a clause of, or Schedule to, this debenture and references to paragraphs are to paragraphs of the relevant Schedule;
- 1.2.5 a reference to this debenture (or any specified provision of it) or any other document shall be construed as a reference to this debenture, that provision or that document as in force for the time being and as amended or novated from time to time;
- 1.2.6 a reference to a person shall include a reference to an individual, firm, corporation, unincorporated body of persons, or any state or any agency of a person;
- 1.2.7 a reference to an amendment includes a supplement, variation, novation, extension, restatement or re-enactment (and amended shall be construed accordingly);
- 1.2.8 a reference to assets includes present and future properties, undertakings, revenues, rights and benefits of every description;
- 1.2.9 a reference to an authorisation includes an authorisation, consent, licence, approval, resolution, exemption, filing, registration and notarisation;
- 1.2.10 a reference to a regulation includes any regulation, rule, official directive, request or guideline (whether or not having the force of law) of any governmental, inter-governmental or supranational body, agency, department or regulatory, self-

regulatory or other authority or organisation;

- 1.2.11 clause, schedule and paragraph headings shall not affect the interpretation of this debenture;
- 1.2.12 references to this debenture and other documents referred to in it include any supplemental or collateral document to each of them or which is entered into pursuant to each of them and any document varying, supplementing, novating or replacing the same from time to time;
- 1.2.13 each provision shall be severable and distinct from one another;
- 1.2.14 a reference to a party shall include that party's successors, permitted assigns and permitted transferees and this Agreement shall be binding on, and enure to the benefit of, the parties to this Agreement and their respective successors, permitted assigns and permitted transferee;
- 1.2.15 any words following the terms **including, include, in particular, for example** or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms; and
- 1.2.16 any powers given in this debenture to an Administrator shall apply to the fullest extent permitted by the Insolvency Act 1986.

### 1.3 Secured Liabilities

- 1.3.1 References in this debenture to the Secured Liabilities shall be construed in relation to the Financing Documents so as to include:
  - 1.3.1.1 any increase or reduction in any amount made available thereunder and/or any alteration and/or addition to the purposes for which any such amount, or increased or reduced amount, may be used;
  - 1.3.1.2 any facilities provided in substitution for or in addition to the facilities originally made available thereunder;
  - 1.3.1.3 any rescheduling of the indebtedness incurred thereunder whether in isolation or in connection with any of the foregoing; and
  - 1.3.1.4 any combination of any of the foregoing,

### 1.4 Inconsistency

If there is any conflict or inconsistency between any provision of this debenture and any provision of the Loan Agreement, the provision of the Loan Agreement shall prevail.

### 1.5 Clawback

If the Creditor considers that an amount paid by the Chargor in respect of the Secured Liabilities is capable of being avoided or otherwise set aside on the liquidation or administration of the Chargor or otherwise, then that amount shall not be considered to have been irrevocably paid for the purposes of this debenture.

### 1.6 Nature of security over real property

A reference in this debenture to a charge or mortgage of any freehold, leasehold or commonhold property includes:

- 1.6.1 all buildings and fixtures (including trade and tenant's fixtures) which are situated on that property at any time;
- 1.6.2 the proceeds of the sale of any part of that property; and
- 1.6.3 the benefit of any covenants for title given, or entered into, by any predecessor in

title of the Chargor in respect of that property, and any monies paid or payable in respect of those covenants.

#### 1.7 Third party rights

A third party has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce, or to enjoy the benefit of, any term of this debenture.

#### 1.8 Perpetuity period

If the rule against perpetuities applies to any trust created by this debenture, the perpetuity period shall be 125 years (as specified by section 5(1) of the Perpetuities and Accumulations Act 2009).

#### 1.9 Insolvency Act 1986

Paragraph 14 of Schedule B1 of the Insolvency Act 1986 (as inserted by section 248 of, and Schedule 16 to, the Enterprise Act 2002) applies to the floating charge created by this debenture.

#### 1.10 Schedules

The schedules form part of this debenture and shall have effect as if set out in full in the body of this debenture. Any reference to this debenture includes the schedules.

#### 1.11 Deed of Priority

This debenture is subject to the terms and conditions of the Deed of Priority.

#### 1.12 Loan Agreement

For the purposes of the Loan Agreement this debenture is a Finance Document (as defined in the Loan Agreement).

### 2 **Covenant to Pay**

The Chargor shall, on demand, pay to the Creditor and discharge the Secured Liabilities when they become due.

### 3 **Grant of Security**

#### 3.1 Charging clause

As a continuing security for the payment and discharge of the Secured Liabilities, the Chargor with full title guarantee, charges to the Creditor or in respect of clause 3.1.3 and 3.1.4 assign by way of security to the Creditor, all of their present and future right, title and interest in and to the following assets which are at any time owned by the Chargor, or in which they from time to time has an interest:

3.1.1 by way of legal mortgage, all estates and interests in any freehold or leasehold property wherever situate now belonging to it including, without limitation, the Properties;

3.1.2 by way of fixed charge:

3.1.2.1 all Properties acquired by the Chargor in the future;

3.1.2.2 all present and future interests of the Chargor not effectively mortgaged or charged under the provisions of clauses 3.1.1 and/or 3.1.2.1 in, or over, freehold or leasehold property;

3.1.2.3 all present and future rights, licences, guarantees, rents, deposits, contracts, covenants and warranties relating to the Properties;

3.1.2.4 all licences, consents and authorisations (statutory or otherwise) held or required in connection with the Chargor's business or the use of any Charged Property, and all rights in connection with them;

- 3.1.2.5 all present and future goodwill and uncalled capital for the time being of the Chargor;
    - 3.1.2.6 all the Equipment;
    - 3.1.2.7 all the Intellectual Property;
    - 3.1.2.8 all the Book Debts;
    - 3.1.2.9 all the Investments, and
    - 3.1.2.10 all monies from time to time standing to the credit of their accounts with any bank, financial institution or other person (including each Designated Account);
  - 3.1.3 all its rights in any policies of insurances or assurance present or future (including, without limitation, any insurances relating to the Properties or the Equipment);
  - 3.1.4 all its rights and interest in the US Receivables (to the extent not assigned to STB under the STB Loan Documents or STB Security Documents or otherwise reassigned by STB); and
  - 3.1.5 by way of floating charge, all the undertaking, property, assets and rights of the Chargor at any time not effectively mortgaged, charged or assigned pursuant to clause 3.1.1 to clause 3.1.4 inclusive.
- 3.2 Leasehold security restrictions
- 3.2.1 Subject to clause 3.2.2 to clause 3.2.4, the security created by clause 3.1 shall not apply to an Excluded Property until the Chargor obtains any relevant consent, or waiver of any prohibition, to the creation of security over that Excluded Property.
  - 3.2.2 In relation to each Excluded Property, the Chargor undertakes to:
    - 3.2.2.1 apply for the relevant consent or waiver of prohibition within five Business Days of the date of this debenture, and to use its reasonable endeavours to obtain that consent or waiver as soon as possible;
    - 3.2.2.2 keep the Creditor informed of its progress in obtaining that consent or waiver; and
    - 3.2.2.3 immediately on receipt of the consent or waiver, provide the Creditor with a copy of that consent or waiver.
  - 3.2.3 Immediately on receipt by the Chargor of the relevant consent or waiver, that Excluded Property shall become the subject of a mortgage or charge (as appropriate) pursuant to clause 3.1.
  - 3.2.4 If required by the Creditor at any time following receipt of that consent or waiver, the Chargor shall, at its own cost, prepare and execute any further documents and take any further action the Creditor may require, in its absolute discretion, for perfecting its security over that Excluded Property.
- 3.3 Automatic conversion of floating charge
- The floating charge created by clause 3.1.5 shall automatically and immediately (without notice) be converted into a fixed charge over the relevant Charged Property if:
- 3.3.1 the Chargor:
    - 3.3.1.1 creates, or attempts to create, over all or any part of the Charged Property an Encumbrance without the prior written consent of the Creditor or any trust in favour of another person save for any Encumbrance created by the STB Security Documents; or
    - 3.3.1.2 disposes, or attempts to dispose of, all or any part of the Charged

Property (other than property that is only subject to the floating charge while it remains uncrystallised which property may be disposed of in the ordinary course of business) save for any disposal made to STB under the STB Loan Documents; or

- 3.3.2 a receiver is appointed over all or any of the Charged Property that is subject to the floating charge; or
- 3.3.3 any person levies (or attempts to levy) any distress, attachment, execution or other process against all or any part of the Charged Property; or
- 3.3.4 the Creditor receives notice of the appointment of, or a proposal or an intention to appoint, an administrator of the Chargor.

#### 3.4 Part A1 moratorium

- 3.4.1 Subject to clause 3.4.2, the floating charge created by clause 3.1.5 may not be converted into a fixed charge solely by reason of obtaining a moratorium (or anything done with a view to obtaining a moratorium) under Part A1 of the Insolvency Act 1986.
- 3.4.2 Clause 3.4.1 does not apply to any floating charge referred to in section A52(4) of Part A1 of the Insolvency Act 1986.

#### 3.5 Conversion of floating charge by notice

The Creditor may, in its sole discretion, at any time and by written notice to the Chargor, convert the floating charge created under this debenture into a fixed charge as regards any part of the Charged Property specified by the Creditor in that notice. If such notice does not specify which Charged Property is the subject of the fixed charge, then the floating charge created by clause 3.1.5 shall be converted into a fixed charge over all of the relevant Charged Property that is referred in clause 3.1.5.

#### 3.6 Assets acquired after any floating charge crystallisation

Any asset acquired by the Chargor after any crystallisation of the floating charge created under this debenture which, but for such crystallisation, would be subject to a floating charge shall (unless the Creditor confirms in writing to the contrary) be charged to the Creditor by way of fixed charge.

### 4 Liability of the Chargor and Preservation of Security

#### 4.1 Liability not discharged

The Chargor's liability under this debenture in respect of any of the Secured Liabilities shall not be discharged, prejudiced or affected by:

- 4.1.1 any security, guarantee, indemnity, remedy or other right held by, or available to, the Creditor that is or becomes wholly or partially illegal, void or unenforceable on any ground; or
- 4.1.2 the Creditor renewing, determining, varying or increasing any facility or other transaction in any manner or concurring in, accepting or varying any compromise, arrangement or settlement, or omitting to claim or enforce payment from any other person; or
- 4.1.3 any other act or omission, which but for this clause 4.1 might have discharged, or otherwise prejudiced or affected, the liability of the Chargor.

#### 4.2 Immediate recourse

The Chargor waives any right it may have to require the Creditor to enforce any security or other right, or claim any payment from, or otherwise proceed against, any other person before enforcing this debenture against the Chargor.

## 4.3 Reinstatement

If any discharge, release or arrangement (whether in respect of the obligations of any Obligor or any security for those obligations or otherwise) is made by the Creditor in whole or in part on the basis of any payment, security or other disposition which is avoided or must be restored in insolvency, liquidation, administration or otherwise, without limitation, then the liability of the Chargor under this debenture will continue or be reinstated as if the discharge, release or arrangement had not occurred.

## 4.4 Waiver of defences

The obligations of the Chargor under this debenture will not be affected by any act, omission, matter or thing which, but for this clause 4, would reduce, release or prejudice any of their obligations under this debenture including (without limitation and whether or not known to it or the Creditor):

- 4.4.1 any time or waiver granted to, or composition with, any Obligor or other person;
- 4.4.2 the release of any Obligor or any other person under the terms of any composition or arrangement with the Creditor;
- 4.4.3 the taking, variation, compromise, exchange, renewal or release of, or refusal or neglect to perfect, take up or enforce, any rights against, or security over assets of, any Obligor or other person or any non-presentation or non-observance of any formality or other requirement in respect of any instrument or any failure to realise the full value of any security;
- 4.4.4 any incapacity or lack of power, authority or legal personality of or dissolution or change in the members or status of an Obligor or any other person;
- 4.4.5 any amendment of any Financing Document or any other document or security including without limitation any change in the purpose of, any extension of or any increase in any facility or the addition of any new facility under any Financing Document or other document or security;
- 4.4.6 any unenforceability, illegality, invalidity or non-provability of any obligation of any person under any Financing Document or any other document or security; or
- 4.4.7 any insolvency or similar proceedings.

## 4.5 Deferral of the Chargor's rights

Unless the Security Period has expired or the Creditor otherwise directs, the Chargor will not exercise any rights which it may have by reason of performance by it of its obligations under this debenture or by reason of any amount being payable, or liability arising, under this debenture:

- 4.5.1 to be indemnified by an Obligor;
- 4.5.2 to claim any contribution from any other person who has provided security or a guarantee in respect of any Obligor's obligations under the Financing Documents;
- 4.5.3 to take the benefit (in whole or in part and whether by way of subrogation or otherwise) of any rights of the Creditor under the Financing Documents or of any other guarantee or security taken pursuant to, or in connection with, the Financing Documents by the Creditor;
- 4.5.4 to bring legal or other proceedings for an order requiring any Obligor to make any payment, or perform any obligation, in respect of which the Chargor has granted security under this debenture;
- 4.5.5 to exercise any right of set-off against any Obligor; and/or
- 4.5.6 to claim or prove as a creditor of any Obligor in competition with the Creditor.

## EXECUTION

If the Chargor receives any benefit, payment or distribution in relation to such rights it shall hold that benefit, payment or distribution to the extent necessary to enable all amounts which may be or become payable to the Creditor by the Obligors under or in connection with the Financing Documents to be repaid in full on trust for the Creditor and shall promptly pay or transfer the same to the Creditor or as the Creditor may direct for application in accordance with the terms of this debenture.

#### 4.6 Security held by Chargor

The Chargor shall not, without the prior consent of the Creditor, hold any security from any other Obligor in respect of the Chargor's liability under this debenture. The Chargor shall hold any security held by it in breach of this provision on trust for the Creditor.

### 5 Representations and Warranties

The Chargor represents and warrants to the Creditor in the terms set out in 2. The representations and warranties set out in Schedule 2 are made on the date of this debenture and are deemed to be repeated by the Chargor on each day during the Security Period with reference to the facts and circumstances then existing.

### 6 Covenants

The Chargor covenants with the Creditor in the terms set out in Schedule 3.

### 7 Powers of the Creditor

7.1 The Creditor shall have the powers set out in Schedule 4.

#### 7.2 Creditor's exercise of rights

After the Creditor:

7.2.1 has taken steps to enforce the security constituted by this debenture after such security has become enforceable; and

7.2.2 has also given notice to the Chargor (such notice to be effective immediately upon receipt or, if earlier, deemed receipt by the Chargor) that the Creditor asserts the right to exercise the rights in this clause 7.2,

then:

7.2.3 the Creditor may at its discretion (in the name of the Chargor or otherwise and without any consent or authority from the Chargor) in order to protect or preserve the security under this debenture exercise the following rights and powers in respect of the Investments:

7.2.3.1 any voting rights and any powers or rights which may be exercised by a person in whose name the Investments are registered; and

7.2.3.2 all the powers exercisable by a trustee in respect of securities or property subject to a trust; and

7.2.4 all voting and other rights and powers attaching to the Investments shall be exercised by, or at the direction of, the Creditor and the Chargor shall, and shall procure that its nominees shall, comply with any directions the Creditor may, in its absolute discretion, give concerning the exercise of those rights and powers in order to protect or preserve the security under this debenture.

#### 7.3 Dividends, etc.

Until the Creditor gives notice to the contrary to the Chargor, the Chargor is permitted to allow the entity to which such Investments relate to pay dividends to the Chargor in relation to the Investments. The Creditor undertakes not to give such notice unless the security constituted by this debenture has become enforceable. After the security constituted by this debenture has become

enforceable and such notice has been given all dividends, interest and other distributions paid in respect of the Investments shall be paid by the Chargor or at its direction into the Designated Account or, if received by the Creditor, may be applied by the Creditor as though they were the proceeds of sale.

## **8 Enforcement**

### **8.1 Enforcement events**

The security constituted by this debenture shall be immediately enforceable upon the occurrence of any of the circumstances set out in paragraph 1 of Schedule 5.

### **8.2 Receiver's powers**

A Receiver shall have, in addition to the powers conferred on receivers by statute, the further powers set out in Schedule 6.

### **8.3 Right of appropriation**

To the extent that the Charged Property constitutes Financial Collateral and this debenture and the obligations of the Chargor hereunder constitute a Security Financial Collateral Arrangement, the Creditor shall have the right, at any time after the security constituted by this debenture has become enforceable (on the occurrence of any of the circumstances set out in paragraph 1 of Schedule 5), to appropriate all or any of that Charged Property in or towards the payment and/or discharge of the Secured Liabilities in such order as the Creditor in its absolute discretion may from time to time determine. The value of any Charged Property appropriated in accordance with this clause shall be the price of that Charged Property at the time the right of appropriation is exercised as listed on any recognised market index, or determined by such other method as the Creditor may select (including independent valuation). The Chargor agrees that the methods of valuation provided for in this clause are commercially reasonable for the purposes of the Financial Collateral Regulations.

## **9 Costs and Indemnity**

### **9.1 Costs**

The Chargor shall pay to, or reimburse, the Creditor and any Receiver on demand, on a full indemnity basis all Costs incurred by the Creditor and/or any Receiver in relation to:

- 9.1.1 this debenture or the Charged Property;
- 9.1.2 taking, holding, protecting, perfecting, monitoring, preserving or enforcing (or attempting to do so) any of the Creditor's or Receiver's rights, powers or discretions under this debenture;
- 9.1.3 suing for, or recovering, any of the Secured Liabilities;
- 9.1.4 any release of any security constituted by this debenture; and/or
- 9.1.5 taking proceedings for, or recovering any of the Secured Liabilities,

(including, without limitation, the Costs of any proceedings in relation to this debenture or the Secured Liabilities), together with interest on any amount due under clause 9.1.2 and clause 9.1.3:

- (a) at the rate and in the manner specified in the Loan Agreement (and if more than one rate shall be specified in the Loan Agreement, the higher of such rates in the manner provided in the Loan Agreement); or
- (b) (if such document is no longer in effect or for any reason interest is not payable under such document) at the rate of 17% per annum. In the case of interest falling under this paragraph (b), such interest shall be payable after as well as before

judgment and shall accrue on a day-to-day basis calculated by the Creditor upon such terms as the Creditor may from time to time determine and shall be compounded on the last Business Day of each month,

and all such accrued interest shall be payable without the need for any demand for payment being made.

## **9.2 Indemnity**

The Creditor and any Receiver, and their respective employees and agents, shall be indemnified on a full indemnity basis out of the Charged Property in respect of all actions, liabilities and Costs incurred or suffered in or as a result of:

- 9.2.1 the preservation or attempted preservation, or exercise or purported exercise, or enforcement and/or attempted enforcement of any of the powers, authorities or discretions vested in them under this debenture;
- 9.2.2 taking, holding or releasing (or attempting to do so) any of the powers, authorities or discretion vested in them under this debenture;
- 9.2.3 dealing with or obtaining advice concerning any matter or question in connection with or arising out of or in relation to this debenture;
- 9.2.4 any matter or thing done, or omitted to be done, in relation to the Charged Property under those powers;
- 9.2.5 any default or delay by the Chargor in performing any of its obligations under this debenture; and/or
- 9.2.6 dealing with any amendment, consent, waiver or other request required by the Chargor from time to time in relation to any Financing Document.

## **10 Release**

Subject to clause 12.3, on the expiry of the Security Period (but not otherwise), the Creditor shall, at the request and cost of the Chargor, take whatever action is necessary to release the Charged Property from the security constituted by this debenture.

## **11 Assignment and Transfer**

- 11.1 At any time, without the consent of the Chargor, the Creditor may assign or transfer the whole or any part of the Creditor's rights and/or obligations under this debenture to any person.
- 11.2 The Chargor may not assign any of its rights, or transfer any of its obligations, under this debenture or enter into any transaction, which would result in any of those rights or obligations passing to another person.

## **12 Further provisions**

### **12.1 Independent security**

This debenture shall be in addition to, and independent of, every other security or guarantee which the Creditor may hold for any of the Secured Liabilities at any time. No prior security held by the Creditor over the whole or any part of the Charged Property shall merge in the security created by this debenture.

### **12.2 Continuing security**

This debenture shall remain in full force and effect as a continuing security for the Secured Liabilities, despite any settlement of account, or intermediate payment, or other matter or thing, unless and until the Creditor discharges this debenture in writing.

### **12.3 Discharge conditional**

## EXECUTION

Any release, discharge or settlement between the Chargor and the Creditor shall be deemed conditional on no payment or security received by the Creditor in respect of the Secured Liabilities being avoided, reduced or ordered to be refunded pursuant to any law relating to insolvency, bankruptcy, winding-up, administration, receivership or otherwise. Despite any such release, discharge or settlement:

12.3.1 the Creditor or its nominee may retain this debenture and the security created by or pursuant to it, including all certificates and documents relating to the whole or any part of the Charged Property, for such period as the Creditor deems necessary to provide the Creditor with security against any such avoidance, reduction or order for refund; and

12.3.2 the Creditor may recover the value or amount of such security or payment from the Chargor subsequently as if such release, discharge or settlement had not occurred.

#### 12.4 Certificates

A certificate or determination by the Creditor as to any amount for the time being due to it from the Chargor under this debenture shall (in the absence of any manifest error) be conclusive evidence of the amount due.

#### 12.5 Rights cumulative

The rights and powers of the Creditor conferred by this debenture are cumulative, may be exercised as often as the Creditor considers appropriate, and are in addition to its rights and powers under the general law.

#### 12.6 Waivers

Any waiver or variation of any right by the Creditor (whether arising under this debenture or under the general law) shall only be effective if it is in writing and signed by the Creditor and applies only in the circumstances for which it was given, and shall not prevent the Creditor from subsequently relying on the relevant provision.

#### 12.7 Further exercise of rights

No act or course of conduct or negotiation by or on behalf of the Creditor shall, in any way, preclude the Creditor from exercising any right or power under this debenture or constitute a suspension or variation of any such right or power.

#### 12.8 Delay

No delay or failure to exercise any right or power under this debenture shall operate as a waiver.

#### 12.9 Single or partial exercise

No single or partial exercise of any right under this debenture shall prevent any other or further exercise of that or any other right.

#### 12.10 Consolidation

The restriction on the right of consolidation contained in section 93 of the Law of Property Act 1925 shall not apply to this debenture.

#### 12.11 Partial invalidity

The invalidity, unenforceability or illegality of any provision (or part of a provision) of this debenture under the laws of any jurisdiction shall not affect the validity, enforceability or legality of the other provisions. If any invalid, unenforceable or illegal provision would be valid, enforceable or legal if some part of it were deleted, the provision shall apply with any modification necessary to give effect to the commercial intention of the parties.

#### 12.12 Counterparts

11.1.2 not, without the prior written consent of the Creditor, withdraw any amounts standing to the credit of any Designated Account; and

11.1.3 if called on so to do by the Creditor, execute a legal assignment of the Book Debts to the Creditor in such terms as the Creditor may require and give notice of that assignment to the debtors from whom the Book Debts are due, owing or incurred.

11.2 Notwithstanding clause 11.1, all amounts received by the Chargor in respect of US Receivables to the extent not paid into an account in accordance with the STB Security Documents or the STB Loan Documents (or to the extent returned by STB) shall be paid directly into a Designated Account and may not be withdrawn without the prior written consent of the Creditor and pending receipt into a Designated Account shall be held on trust for the Creditor.

**12 Insurance covenant**

12.1 The Chargor shall:

12.1.1 insure and keep insured (or where, in the case of any leasehold property, insurance is the responsibility of the landlord under the terms of the lease, either procure that the landlord insures and keeps insured or, if and to the extent that the landlord does not do so, itself insure and keep insured) all of its undertaking and assets with reputable and responsible insurers previously approved by the Creditor in such manner and to such extent as is reasonable and customary for an enterprise engaged in the same or similar business and in the same or similar localities against such risks and contingencies as the Creditor shall from time to time request;

12.1.2 procure (within 10 Business Days of the date of this debenture) that the interest of the Creditor is noted on all those Insurance Policies or, at the option of the Creditor, that any of the Insurance Policies are issued in the joint names of the Creditor and the Chargor; and

12.1.3 duly and punctually pay all premiums and any other monies necessary for maintaining its insurance in full force and effect.

12.2 The Chargor:

12.2.1 shall (if the Creditor so requires) produce to, or deposit with, the Creditor all Insurance Policies and the receipts for all premiums and other payments necessary for effecting and keeping up such policies (or where, in the case of leasehold property, insurance is effected by the landlord, such evidence of the payment of premiums as the Chargor is entitled to obtain from the landlord under the terms of the relevant lease); and

12.2.2 has not done or omitted to do, and shall not do or omit to do, any act or thing that

may invalidate or otherwise prejudice the Insurance Policies.

### **13 Insurance Policies' proceeds**

All sums payable under any of the Insurance Policies at any time (whether or not the security constituted by this debenture has become enforceable) shall:

- 13.1 be applied in making good or recouping expenditure in respect of the loss or damage for which those monies are received; or
- 13.2 after the security constituted by this debenture has become enforceable (on the occurrence of the circumstances set out in paragraph 1 of Schedule 5) and if the Creditor so directs, in or towards discharge or reduction of the Secured Liabilities.

## **Part 3. Property covenants**

### **14 Maintenance and insurance**

The Chargor shall keep all buildings and all fixtures on each Property in good and substantial repair and condition;

### **15 Preservation of Property, fixtures and equipment**

The Chargor shall not, without the prior written consent of the Creditor:

- 15.1 pull down or remove the whole or any part of any building forming part of any Property; or
- 15.2 make any material alterations to any Property or sever or remove any of its fixtures; or
- 15.3 remove or make any material alterations to any of the Equipment belonging to, or in use by, the Chargor on any Property (except to affect necessary repairs or replace them with new or improved models or substitutes); or
- 15.4 whenever any Equipment is destroyed, damaged or deteriorates, immediately repair, replace and make good the same.

### **16 Conduct of business on Properties**

The Chargor shall carry on its trade and business in accordance with the standards of good management from time to time current in such trade or business on those parts (if any) of the Properties as are or may be used for the purposes of trade or business.

### **17 Planning information**

The Chargor shall:

- 17.1 give full particulars to the Creditor of any notice, order, direction, designation, resolution or proposal given or made by any planning authority or other public body or authority ("**Planning Notice**") that specifically applies to any Property, or to the locality in which it is situated, within seven days after becoming aware of the relevant Planning Notice; and
- 17.2 (if the Creditor so requires) immediately, and at the cost of the Chargor, take all reasonable and necessary steps to comply with any Planning Notice, and make, or join with the Creditor in making, such objections or representations in respect of any such Planning Notice as the Creditor may desire.

### **18 Compliance with covenants and payment of rent**

The Chargor shall:

- 18.1 observe and perform all covenants, stipulations and conditions to which each Property, or the use of it, is or may be subjected and (if the Creditor so requires) produce to the Creditor evidence sufficient to satisfy the Creditor that those covenants, stipulations and conditions

## EXECUTION

have been observed and performed; and

- 18.2 (without prejudice to the generality of the foregoing) where a Property, or part of it, is held under a lease, duly and punctually pay all rents due from time to time and perform and observe all of the tenant's covenants and conditions.

**19 Maintenance of interests in Properties**

The Chargor shall not, without the prior written consent of the Creditor:

- 19.1 grant, or agree to grant, any licence or tenancy affecting the whole or any part of any Property, or exercise the statutory powers of leasing (or agreeing to lease) or of accepting (or agreeing to accept) surrenders under sections 99 or 100 of the Law of Property Act 1925; or
- 19.2 in any other way dispose of, or agree to dispose of, surrender or create any legal or equitable estate or interest in the whole or any part of any Property.

**20 Registration restrictions**

The Chargor shall procure that no person shall be registered under the Land Registration Acts 1925 to 2002 as proprietor of any Property without the prior written consent of the Creditor. The Chargor shall be liable for the Costs of the Creditor in lodging cautions against the registration of the title to the whole or any part of any Property from time to time.

**21 Development restrictions**

The Chargor shall not, without the prior written consent of the Creditor, carry out or permit or suffer to be carried out on any Property any development as defined in the Town and Country Planning Act 1990 or change or permit or suffer to be changed the use of any Property.

**22 Environment**

The Chargor shall:

- 22.1 properly discharge all duties of care and responsibility placed upon it by Environmental Law;
- 22.2 observe and perform all requirements of Environmental Law both in the conduct of its general business and in the management, possession or occupation of each Property; and
- 22.3 apply for and obtain all authorisations, necessary to ensure that it does not breach Environmental Law.

**23 No restrictive obligations**

The Chargor shall not, without the prior written consent of the Creditor enter into any onerous or restrictive obligations affecting the whole or any part of any Property or create or permit to arise any overriding interest, easement or right whatever in or over the whole or any part of any Property.

**24 Proprietary rights**

The Chargor shall procure that no person shall become entitled to assert any proprietary or other like right or interest over the whole or any part of any Property without the prior written consent of the Creditor.

**25 Inspection**

The Chargor shall permit the Creditor and any Receiver and any person appointed by either of them to enter on and inspect any Property on reasonable prior notice.

**26 Property information**

## EXECUTION

The Chargor shall inform the Creditor promptly of any acquisition by the Chargor of, or contract made by the Chargor to acquire, any freehold, leasehold or other interest in any property.

**27 VAT option to tax**

27.1 The Chargor shall not, without the prior written consent of the Creditor:

27.1.1 exercise any VAT option to tax in relation to any Property; or

27.1.2 revoke any VAT option to tax exercised, and disclosed to the Creditor, before the date of this debenture.

**28 Registration at HM Land Registry**

28.1 The Chargor consents to an application being made by the Creditor to the Land Registrar for the following restriction in Form P to be registered against its title to each Property:

"No disposition of the registered estate by the proprietor of the registered estate or by the proprietor of any registered charge, not being a charge registered before the entry of this restriction is to be registered without a written consent signed by the proprietor for the time being of the charge dated [DATE] in favour of JCP Five Limited referred to in the charges register."

**Part 4. Equipment covenants****29 Maintenance of Equipment**

The Chargor shall:

29.1 maintain the Equipment in good and serviceable condition (except for expected fair wear and tear); and

29.2 not to permit any Equipment to be:

29.2.1 used or handled, other than by properly qualified and trained persons; or

29.2.2 to be overloaded or used for any purpose for which it is not designed or reasonably suitable.

**30 Payment of Equipment taxes**

The Chargor shall promptly pay all taxes, fees, licence duties, registration charges, insurance premiums and other outgoings in respect of the Equipment and, on demand, produce evidence of payment to the Creditor.

**31 Equipment information**

The Chargor shall:

31.1 give the Creditor such information concerning the location, condition, use and operation of any Equipment as the Creditor may require; and

31.2 permit any persons designated by the Creditor to inspect and examine any Equipment and the records relating to any Equipment at all reasonable times.

**32 Equipment insurance**

The Chargor shall:

32.1 at its own expense, procure that the Equipment is covered and kept covered by insurance of

## EXECUTION

a kind satisfactory to the Creditor with insurers approved by the Creditor (such approval not to be unreasonably withheld) for full comprehensive insurance cover, which shall include (but not be limited to) fire, theft and accident, for an amount which is not less than the aggregate cost of reinstating or replacing such Equipment;

- 32.2 if the Creditor so requires, procure that the interest of the Creditor is noted on all such insurance policies or, at the option of the Creditor, that such insurance policies are issued in the joint names of the Creditor and the Chargor; and
- 32.3 maintain insurance for third party liabilities in such amount, and on such terms, as is usual for users of equipment of the same type as the relevant item of Equipment.

### **33 Notice of charge**

The Chargor shall, if so requested by the Creditor, place and maintain on each item of Equipment, in a conspicuous place, a clearly legible identification plate containing the following wording:

"NOTICE OF CHARGE

This [DESCRIPTION OF ITEM] and ancillary equipment is subject to a fixed charge dated [DATE ] in favour of JCP Five Limited".

## **Part 5. Intellectual Property covenants**

### **34 Preservation of rights**

The Chargor shall take all necessary action to safeguard and maintain present and future rights in, or relating to, the Intellectual Property including (without limitation), observing all covenants and stipulations relating to such rights and paying all applicable renewal fees, licence fees and other outgoings.

### **35 Registration of Intellectual Property**

The Chargor shall use all reasonable efforts to effect registration of applications for registration of any Intellectual Property and keep the Creditor informed of all matters relating to such registration.

### **36 Maintenance of Intellectual Property**

The Chargor shall not permit any Intellectual Property to be abandoned, cancelled or to lapse.

## **Part 6. Investments**

### **37 Registration of Investments**

The Chargor shall:

- 37.1 terminate with immediate effect all nominations it may have made under sections 145 and 146 of the Companies Act 2006 in respect of any Investments and pending such termination procure that any person so nominated:
- 37.1.1 does not exercise any rights in respect of any Investments without the prior written approval of the Creditor; and
- 37.1.2 immediately upon receipt, forward to the Creditor all communications or other information received in respect of any Investments for which it has been so nominated; and

## EXECUTION

37.1.3 at the direction of the Creditor given at any time, immediately execute and deliver to the Creditor all transfers and other documents and do all such things as may be necessary or desirable to register all or any of the Investments in the name of the Creditor or its nominee.

37.2 The Chargor shall not during the Security Period exercise any rights under sections 145 and 146 of the Companies Act 2006 to nominate any person in respect of any of the Investments.

### **38 Additional registration obligations**

The Chargor shall:

38.1 procure all consents, waivers, approvals and permissions which are necessary, under the articles of association of any issuer that is not a public company or otherwise, for the transfer of the Investments to the Creditor or its nominee, or to a purchaser on enforcement of this debenture; and

38.2 procure the amendment of the share transfer provisions of the articles of association of each issuer that is not a public company in such manner as the Creditor may require in order to permit such a transfer.

### **39 Dividends and voting rights post enforcement**

After the security constituted by this debenture has become enforceable:

39.1 all dividends and other distributions paid in respect of the Investments and received by the Chargor shall be held on trust for the Creditor and immediately paid into a Designated Account or, if received by the Creditor, shall be retained by the Creditor; and

39.2 all voting and other rights and powers attaching to the Investments shall be exercised by, or at the direction of, the Creditor and the Chargor shall, and shall procure that its nominees shall, comply with any directions the Creditor may, in its absolute discretion, give concerning the exercise of those rights and powers in order to protect or preserve its security under this debenture.

### **40 Calls on Investments**

The Chargor shall duly and promptly pay all calls, instalments and other monies which may be payable from time to time in respect of the Investments. The Chargor acknowledge that the Creditor shall not be under any liability in respect of any such calls, instalments or other monies.

### **41 No alteration of Investments**

The Chargor shall not, without the prior written consent of the Creditor, amend, or agree to the amendment of, the memorandum or articles of association or any other constitutional documents of any issuer that is not a public company, or the rights or liabilities attaching to any of the Investments.

### **42 Preservation of Investments**

The Chargor shall ensure (insofar as it is able to by the exercise of all voting rights, powers of control and other means available to it) that no issuer that is not a public company shall:

42.1 consolidate or subdivide any of its Investments, or reduce or re-organise its share capital in any way;

42.2 issue any new shares or stock; or

42.3 refuse to register any transfer of any of its Investments, which may be lodged for registration by, or on behalf of, the Creditor or the Chargor in accordance with this debenture.

### **43 Investments information**

The Chargor shall, send to the Creditor copies of all notices, circulars, reports, accounts and

EXECUTION

other documents, which are sent to holders generally of any Investments, promptly following receipt.

**Schedule 4 : Powers of the Creditor****1 Power to remedy**

The Creditor shall be entitled (but shall not be bound) to remedy a breach at any time by the Chargor of any of its obligations contained in this debenture and the Chargor irrevocably authorises the Creditor and its agents to do all such things as are necessary or desirable for that purpose.

**2 Exercise of rights**

The rights of the Creditor under paragraph 1 of this Schedule 4 are without prejudice to any other rights of the Creditor under this debenture. The exercise of those rights shall not make the Creditor liable to account as a mortgagee in possession.

**3 Power to dispose of chattels**

At any time after the security constituted by this debenture has become enforceable (on the occurrence of any of the circumstances set out in paragraph 1 of Schedule 5), the Creditor or any Receiver:

- 3.1 may dispose of any chattels or produce found on any Property as agent for the Chargor; and
- 3.2 without prejudice to any obligation to account for the proceeds of any sale of such chattels or produce, shall be indemnified by the Chargor against any liability arising from such disposal.

**4 Prior Encumbrances**

- 4.1 At any time after the security constituted by this debenture has become enforceable, or after any powers conferred by any Encumbrance having priority to this debenture shall have become exercisable, the Creditor may:

- 4.1.1 redeem such or any other prior Encumbrance, or procure its transfer to itself; and
  - 4.1.2 settle any account of the holder of any prior Encumbrance.

- 4.2 The settlement of any such account shall be conclusive and binding on the Chargor. All monies paid by the Creditor to an encumbrancer in settlement of such an account shall, as from its payment by the Creditor, be due from the Chargor to the Creditor on current account and shall bear interest and be secured as part of the Secured Liabilities.

**5 Conversion of currency**

For the purpose of, or pending the discharge of, any of the Secured Liabilities, the Creditor may convert any monies received, recovered or realised by the Creditor under this debenture (including the proceeds of any previous conversion under this paragraph 5) from their existing currencies of denomination into such other currencies of denomination as the Creditor may think fit. Any such conversion shall be effected at then prevailing spot selling rate of exchange for such other currency against the existing currency. Each reference in this paragraph 5 to a currency extends to funds of that currency and, for the avoidance of doubt, funds of one currency may be converted into different funds of the same currency.

**6 New accounts**

- 6.1 If the Creditor receives notice of any subsequent Encumbrance, or other interest, affecting all or part of the Charged Property, the Creditor may open a new account for the Chargor in the Creditor's books. Without prejudice to the Creditor's right to combine accounts, no money paid to the credit of the Chargor in any such new account shall be appropriated towards, or have the effect of discharging, any part of the Secured Liabilities.



## EXECUTION

- 6.2 If the Creditor does not open a new account immediately on receipt of notice under paragraph 6.1 of this Schedule 4, then, unless the Creditor gives express written notice to the contrary to the Chargor, all payments made by the Chargor to the Creditor shall be treated as having been credited to a new account of the Chargor and not as having been applied in reduction of the Secured Liabilities, as from the time of receipt of the relevant notice by the Creditor.

## **7 Creditor's set-off rights**

- 7.1 If the Creditor has more than one account for the Chargor in its books, the Creditor may at any time after:

- 7.1.1 the security constituted by this debenture has become enforceable; or
- 7.1.2 the Creditor has received notice of any subsequent Encumbrance or other interest affecting all or any part of the Charged Property,

transfer, without prior notice, all or any part of the balance standing to the credit of any account to any other account which may be in debit (but the Creditor shall notify the Chargor of the transfer once made).

- 7.2 Without prejudice to paragraph 7.1 of this Schedule 4 and any right of set-off or combination of accounts contained in any Financing Document, the Creditor may at any time without notice to the Chargor combine or consolidate all or any amounts standing to the credit of the Chargor's account or accounts with the Creditor and/or set off any amount owed by the Creditor to the Chargor against any obligation (whether or not matured) owed to the Creditor by the Chargor whether or not each is expressed in the same currency. The Creditor shall notify the Chargor once the Creditor has exercised its rights under this paragraph 7.2 of this Schedule 4.
- 7.3 Any exercise by the Creditor of its rights under paragraph 7 of this Schedule 4 shall not limit or affect any other rights or remedies available to it under this debenture or otherwise.

## **8 Indulgence**

The Creditor may, at its discretion, grant time or other indulgence or make any other arrangement, variation or release with any person or persons not being a party to this debenture (whether or not such person or persons is jointly liable with the Chargor) in respect of any of the Secured Liabilities, or of any other security for them without prejudice either to this debenture or to the liability of the Chargor for the Secured Liabilities.

## **9 Investments: dividends and voting rights prior to enforcement**

Until the security constituted by this debenture becomes enforceable:

- 9.1 the Creditor shall, on request by the Chargor, release and pay to the Chargor any cash dividends paid in respect of any of the Investments and received by the Creditor or its nominee; and
- 9.2 the Creditor shall, in exercising all voting and other rights and powers of the Creditor or its nominee attaching to the Investments, act in accordance with the directions of the Chargor from time to time if acting in accordance with those directions would not, in the Creditor's opinion, prejudice the Creditor's security under this debenture or the value of the Investments, or contravene any agreement between the Creditor and the Chargor.

**Schedule 5 : Enforcement****1 Enforcement events**

The security constituted by this debenture shall be enforceable if:

- 1.1 if there shall occur any event of default (as such term may be defined the Loan Agreement or in any other document or agreement evidencing Secured Liabilities); or
- 1.2 any of the Secured Liabilities are not paid or discharged upon its due date (whether on demand, at scheduled maturity, or by acceleration or otherwise, as the case may be) unless the Creditor is satisfied that such non payment is due solely to administrative or technical delays in the transmission of funds which is not the fault of the Chargor and payment is made within two Business Days of its due date; or
- 1.3 the Chargor or any other Obligor is in breach of any of its obligations under any Financing Document or under any other agreement between either (i) the Chargor and the Creditor (ii) the Chargor and another Obligor or (iii) another Obligor and the Creditor; or
- 1.4 any representation or warranty made by the Chargor or any other Obligor under any Financing Document or in any notice, certificate, instrument or statement contemplated by or made pursuant to any Financing Document is, or proves to be, untrue or incorrect in any material respect when made or deemed to be repeated; or
- 1.5 if, in relation to an Obligor:
  - 1.5.1 any indebtedness of an Obligor is not paid when due or becomes prematurely payable or capable of being prematurely declared payable or, if such indebtedness is on-demand, a demand is made in respect of that indebtedness, or an Encumbrance over any assets or property of an Obligor becomes enforceable or capable of being enforced;
  - 1.5.2 a mortgagee, chargee or other encumbrancer takes possession of the whole or any part of the Charged Property;
  - 1.5.3 it passes any resolution or takes any corporate action, or a petition is presented or proceedings are commenced, or any action is taken by any person for its winding up, dissolution, administration or re-organisation or for the appointment of a receiver, administrative receiver, trustee or similar officer of it or of any or all of its revenues or assets;
  - 1.5.4 any distress, execution or other process is levied or issued against any Charged Property which is not paid within seven days;
  - 1.5.5 it is unable or admits inability to pay its debts as they fall due within the meaning of section 123 of the Insolvency Act 1986;
  - 1.5.6 it is unable or admits inability to pay its debts as they fall due;
  - 1.5.7 it suspends or threatens to suspend making payments of any of its debts;
  - 1.5.8 it convenes or holds a meeting of its creditors or commences negotiations with one or more of its creditors with a view to the general readjustment or rescheduling of all or any class of its indebtedness or gives notice to any of its creditors that it has suspended or intends to suspend payment of any of its debts;
  - 1.5.9 it has any Charged Property seized by or on behalf of creditors unless they are released from seizure within seven days;
  - 1.5.10 it proposes, or its directors make a proposal for, an arrangement or composition with or for the benefit of its creditors, including a voluntary arrangement under part I of Insolvency Act 1986 or a restructuring plan under Part 26A of the

## EXECUTION

Companies Act 2006;

- 1.5.11 a moratorium is declared in respect of any of its indebtedness or it obtains a moratorium in accordance with Part A1, Insolvency Act 1986 and schedule ZA1 to Insolvency Act 1986 in respect of its indebtedness or anything is done by it or on its behalf for the purposes of obtaining a moratorium. If a moratorium occurs, the ending of the moratorium will not remedy the occurrence of an Enforcement Event caused by that moratorium;
- 1.5.12 an application is made to the court for an administration order under paragraph 12(1) of schedule B1 to the Insolvency Act 1986 or notice is given of intention to appoint an administrator under paragraph 12(2) or 26 of schedule B1 to the Insolvency Act 1986);
- 1.5.13 an administration order is made under paragraph 11 of schedule B1 to Insolvency Act 1986;
- 1.5.14 an administrator is appointed under paragraph 14 or 22 of schedule B1 to the Insolvency Act 1986;
- 1.5.15 it is struck off the register of companies; or
- 1.5.16 any event occurs, under the law of any jurisdiction, which is analogous to any of those set in paragraphs 1.5.3 to 1.5.15 (inclusive) above;
- 1.6 any Obligor ceases to carry on a material part of the business it carries on at the date of this debenture or enters into any new or unrelated business; or
- 1.7 any Obligor fails to comply in any material respect with any environmental or other law or fails to renew or comply with any licence permit consent or other authorisation required for the conduct of its business or any such licence permit consent or other authorisation is revoked, cancelled or suspended; or
- 1.8 any circumstances arise which in the reasonable opinion of the Creditor give grounds for belief that any Obligor may not, or may be unable to, perform or comply with any of its obligations under any Financing Document; or
- 1.9 any representation, warranty or statement made or deemed to be made by the Chargor under this debenture is or proves to have been incorrect or misleading in any material respect when made or deemed to be made,

and in any such circumstance (whether or not the circumstance is continuing), without prejudice to any other rights of the Creditor, the powers of sale under the Law of Property Act 1925 shall immediately be exercisable and the Creditor may, in its absolute discretion, enforce all or any part of the security created by this debenture as it sees fit.

## **2 Statutory power of sale**

The statutory powers of sale conferred by the Law of Property Act 1925 shall, as between the Creditor and a purchaser from the Creditor, arise on and be exercisable at any time after the execution of this debenture, but the Creditor shall not exercise such power of sale until the security constituted by this debenture has become enforceable under paragraph 1 of this Schedule 5.

## **3 Extension of statutory powers**

The statutory powers of sale, leasing and accepting surrenders conferred upon mortgagees under the Law of Property Act 1925 and/or by any other statute shall be exercisable by the Creditor under this debenture and are extended so as to authorise the Creditor, whether in its own name or in that of the Chargor, to grant a lease or agreement to lease, accept surrenders of lease or grant any option of the whole or any part of the freehold and

## EXECUTION

leasehold property of the Chargor with whatever rights relating to other parts of it, containing whatever covenants on the part of the Chargor, generally on such terms and conditions (including the payment of money to a lessee or tenant on a surrender) and whether or not at a premium as the Creditor thinks fit.

#### **4 Protection of third parties**

No purchaser, mortgagee or other person dealing with the Creditor or any Receiver shall be concerned:

- 4.1 to enquire whether any of the Secured Liabilities have become due or payable, or remain unpaid or undischarged, or whether the power the Creditor or a Receiver is purporting to exercise has become exercisable; or
- 4.2 to see to the application of any money paid to the Creditor or any Receiver.

#### **5 No liability as mortgagee in possession**

Neither the Creditor, nor any Receiver nor any Administrator shall be liable to account as mortgagee in possession in respect of all or any of the Charged Property, nor shall any of them be liable for any loss on realisation of, or for any neglect or default of any nature in connection with, all or any of the Charged Property for which a mortgagee in possession might be liable as such.

#### **6 Appointment of Receiver**

- 6.1 At any time after the security constituted by this debenture has become enforceable, or at the request of the Chargor, the Creditor may, without further notice:
  - 6.1.1 appoint by way of deed or otherwise in writing, any one or more person or persons to be a receiver, or a receiver and manager, of all or any part of the Charged Property; and
  - 6.1.2 (subject to section 45 of the Insolvency Act 1986) from time to time, by way of deed or otherwise in writing, remove any person appointed to be Receiver and may, in a similar manner, appoint another in his place.
- 6.2 Where more than one person is appointed Receiver, they shall have power to act separately (unless the appointment by the Creditor specifies to the contrary).
- 6.3 The Creditor may fix the remuneration of any Receiver appointed by it without the restrictions contained in section 109 of the Law of Property Act 1925 and the remuneration of the Receiver shall be a debt secured by this debenture, which shall be due and payable immediately upon its being paid by the Creditor.

#### **7 Power of sale additional**

- 7.1 The powers of sale and appointing a Receiver conferred by this debenture shall be in addition to all statutory and other powers of the Creditor under the Insolvency Act 1986, the Law of Property Act 1925 or otherwise, and shall be exercisable without the restrictions contained in Sections 103 and 109 of the Law of Property Act 1925 or otherwise.
- 7.2 The power to appoint a Receiver (whether conferred by this debenture or by statute) shall be, and remain, exercisable by the Creditor despite any prior appointment in respect of all or any part of the Charged Property.

#### **8 Agent of the Chargor**

Any Receiver appointed by the Creditor under this debenture shall be the agent of the Chargor and the Chargor shall be solely responsible for his acts and remuneration, as well as for any defaults committed by him.

**9 Powers of Receiver**

Any Receiver appointed by the Creditor under this debenture shall, in addition to the powers conferred on him by the Law of Property Act 1925 and the Insolvency Act 1986, have the power to do all such acts and things as an absolute owner could do in the management of such of the Charged Property over which the Receiver is appointed and, in particular, the powers set out in Schedule 6.

**10 Order of application of proceeds**

All monies received by the Creditor or a Receiver in the exercise of any enforcement powers conferred by this debenture shall be applied:

- 10.1 first in paying all unpaid fees, costs and other liability incurred by or on behalf of the Creditor (and any Receiver, attorney or agent appointed by it);
- 10.2 second in paying the remuneration of any Receiver (as agreed between the Receiver and the Creditor);
- 10.3 third in or towards discharge of the Secured Liabilities in such order and manner as the Creditor determines; and
- 10.4 finally in paying any surplus to the Chargor or any other person entitled to it.

**11 Appropriation**

Neither the Creditor nor any Receiver shall be bound (whether by virtue of section 109(8) of the Law of Property Act 1925, which is varied accordingly, or otherwise) to pay or appropriate any receipt or payment first towards interest rather than principal or otherwise in any particular order between any of the Secured Liabilities.

**12 Suspense account**

All monies received by the Creditor or a Receiver under this debenture may, at the discretion of the Creditor or Receiver, be credited to any suspense or securities realised account and shall bear interest at such rate, as may be agreed in writing between the Creditor and the Chargor, and may be held in such account for so long as the Creditor or Receiver thinks fit (save that such monies shall not be held in such an account where they would clear the Secured Liabilities in full).

**13 Power of attorney**

By way of security, the Chargor irrevocably appoints the Creditor and every Receiver separately to be the attorney of such Chargor and, in its name, on its behalf and as its act and deed, to, and only after the security constituted by this debenture has become enforceable (on the occurrence of any of the circumstances set out in paragraph 1 of Schedule 5), execute any documents and do any acts and things which:

- 13.1 the Chargor is required to execute and do under this debenture, including execute any document required by the Creditor under paragraph 7 of Part 1 of Schedule 3; and/or
- 13.2 any attorney may deem proper or desirable in exercising any of the powers, authorities and discretions conferred by this debenture or by law on the Creditor or any Receiver.

**14 Ratification of acts of attorney**

The Chargor ratifies and confirms, and agrees to ratify and confirm, anything, which any of its attorneys may do in the proper and lawful exercise or purported exercise of all or any of the powers, authorities and discretions referred to in paragraph 13 of this Schedule 5.

EXECUTION

**15 Appointment of an Administrator**

- 15.1 The Creditor may, without notice to the Chargor, appoint any one or more persons to be an administrator of the Chargor pursuant to Paragraph 14 Schedule B1 of the Insolvency Act 1986 if the security constituted by this debenture becomes enforceable.
- 15.2 Any appointment under this paragraph 15 shall:
  - 15.2.1 be in writing signed by a duly authorised signatory of the Creditor; and
  - 15.2.2 take effect, in accordance with paragraph 19 of Schedule B1 of the Insolvency Act 1986, when the requirements of paragraph 18 of that Schedule B1 are satisfied.
- 15.3 The Creditor may (subject to any necessary approval from the court) end the appointment of an Administrator by notice in writing in accordance with this paragraph 15 and appoint a replacement for any Administrator whose appointment ends for any reason under that paragraph.

**Schedule 6 : Further powers of a Receiver****1 Power to repair and develop Properties**

A Receiver may undertake or complete any works of repair, building or development on the Properties.

**2 Power to surrender leases**

A Receiver may grant, or accept surrenders of, any leases or tenancies affecting the Properties on such terms and subject to such conditions as he thinks fit.

**3 Power to employ personnel and advisors**

A Receiver may provide services and employ, or engage, such managers, contractors and other personnel and professional advisors on such terms as he deems expedient.

**4 Power to make VAT elections**

A Receiver may make such elections for value added tax purposes as he thinks fit.

**5 Power to charge for remuneration**

A Receiver may charge and receive such sum by way of remuneration (in addition to all costs, charges and expenses incurred by him) as the Creditor may prescribe or agree with him.

**6 Power to realise Charged Property**

A Receiver may collect and get in the Charged Property or any part of it in respect of which he is appointed and make such demands and take such proceedings as may seem expedient for that purpose, and to take possession of the Charged Property with like rights.

**7 Power to manage or reconstruct the Chargor's business**

A Receiver may carry on, manage, develop, reconstruct, amalgamate, diversify, or concur in carrying on, managing, developing, reconstructing, amalgamating or diversifying the business of the Chargor.

**8 Power to dispose of Charged Property**

A Receiver may grant options and licences over all or any part of the Charged Property, sell or concur in selling, assign or concur in assigning, lease or concur in leasing and accept or concur in accepting surrenders of leases of, all or any of the property of the Chargor in respect of which he is appointed in such manner and generally on such terms and conditions as he thinks fit (fixtures and plant and machinery may be severed and sold separately from the premises in which they are contained without the consent of the Chargor), and to carry any such sale, assignment, leasing or surrender into effect. Any such sale may be for such consideration as the Receiver thinks fit and he may promote, or concur in promoting, a company to purchase the property to be sold.

**9 Power to sell Book Debts**

A Receiver may sell and assign all or any of the Book Debts in respect of which he is appointed in such manner, and generally, on such terms and conditions, as he thinks fit.

**10 Power to make settlements**

A Receiver may make any arrangement, settlement or compromise between the Chargor and any other person, which he may think expedient.

## EXECUTION

**11 Power to improve the Equipment**

A Receiver may make substitutions of, or improvements to, the Equipment as he may think expedient.

**12 Power to make calls on Chargor members**

A Receiver may make calls conditionally or unconditionally on the members of the Chargor in respect of the uncalled capital with such and the same powers for that purpose, and for the purpose of enforcing payments of any calls so made, as are conferred by the Articles of Association of the Chargor on its directors in respect of calls authorised to be made by them.

**13 Power to appoint**

A Receiver may appoint managers, officers, servants, workmen and agents for the purposes of this Schedule 6 at such salaries, for such periods and on such terms as he may determine.

**14 Power to insure**

A Receiver may, if he thinks fit, but without prejudice to the indemnity in clause 9 effect with any insurer any policy of insurance either in lieu or in satisfaction of, or in addition to, such insurance.

**15 Powers under Law of Property Act 1925**

A Receiver may exercise all powers provided for in the Law of Property Act 1925 in the same way as if he had been duly appointed under that act, and exercise all powers provided for an administrative receiver in Schedule 1 of the Insolvency Act 1986.

**16 Power to borrow**

A Receiver may for any of the purposes authorised by this Schedule 6 raise money by borrowing from the Creditor (or from any other person) on the security of all or any of the Charged Property in respect of which he is appointed on such terms as he shall think fit (including, if the Creditor consents, terms under which such security ranks in priority to this debenture).

**17 Power to redeem prior Encumbrances**

A Receiver may redeem any prior Encumbrance and settle and pass the accounts to which the Encumbrance relates. Any accounts so settled and passed shall be conclusive and binding on the applicable Chargor(s), and the monies so paid shall be deemed to be an expense properly incurred by him.

**18 Incidental powers**

A Receiver may do all such other acts and things as he may consider incidental or conducive to any of the matters or powers in this Schedule 6, or which he lawfully may or can do as agent for the Chargor.

**19 Scope of powers**

Any exercise of any of the powers given by this Schedule 6 may be on behalf of the Chargor, the directors of the Chargor (in the case of the power contained in paragraph 12 of this Schedule 6) or himself.
