TO ALL MEMBERS, CREDITORS AND THE REGISTRAR OF COMPANIES

1 INTRODUCTION

- 1.1 Martin Maloney and Andrew Poxon were appointed Joint Liquidators of A P R Windows and Conservatories Limited ("the Company") on 27 February 2019.
- 1.2 Martin Maloney and Andrew Poxon are authorised to act as insolvency practitioners in the UK by the Institute of Chartered Accountants in England and Wales.
- 1.3 There has been no change in office holder since the date of Liquidation.
- 1.4 This report provides an update on the conduct of the Liquidation for the period from 27 February 2019 to 26 February 2020, as required by Section 104A(1) of the Insolvency Act 1986 (as amended) ("the Act") and Rule 18.3 of the Insolvency (England and Wales) Rules 2016 ("the Rules"). It contains details of the progress made, the expected outcome for creditors and other information that the Joint Liquidators are required to disclose.
- 1.5 All figures are stated net of VAT.

2 CONDUCT OF THE LIQUIDATION

2.1 The Company's registered office was changed to Leonard Curtis House, Elms Square, Bury New Road, Whitefield, Greater Manchester M45 7TA on 13 March 2019.

Assets Realised

Office Furniture, Equipment, Website and Domain Name

£374 was expected to be received following the sale of the Company's physical assets. The website and domain name had an uncertain realisable value at the date of Liquidation. The Joint Liquidators instructed independent agent, Cerberus Asset Management ("Cerberus"), to provide a valuation of the assets. An offer of £7,500 was received from a connected party by way of a common director. It is not known whether the connected party was separately advised. The Joint Liquidators accepted the offer and £5,000 has been received in this reporting period. Collections remain ongoing at this time.

Bank Interest

2.3 Bank interest of £4 has been received during the period of this report.

Assets Still to be Realised

2.4 The following assets are still to be realised:

2.5 As mentioned at 2.2, collection of the sale consideration remains ongoing at this time.

3 RECEIPTS AND PAYMENTS ACCOUNT

A summary of the Joint Liquidators' receipts and payments for the period from 27 February 2019 to 26 February 2020 is attached at Appendix A.

4 OUTCOME FOR CREDITORS

Secured Creditors

4.1 There are no secured creditors.

Preferential Creditors

- 4.2 As at the date of Liquidation, no preferential claims were anticipated.
- 4.3 No claims have been received.

Prescribed Part

4.4 There is no floating charge creditor and, as a consequence, there is no requirement to pay a prescribed part dividend.

Ordinary Unsecured Creditors

- 4.5 As at the date of Liquidation, there were 21 unsecured creditors, with estimated claims totalling £158,849. Claims totalling £172,487 have been received.
- 4.6 The funds realised have already been distributed or used or allocated for paying the expenses of the Liquidation. As a result, there will be no dividend to ordinary unsecured creditors.
- 4.7 The Joint Liquidators have collated and acknowledged (where requested) the claims of the ordinary unsecured creditors, although, in view of the fact that there will be no distribution to this class of creditor, unsecured claims have not been formally agreed.

5 INVESTIGATIONS

- 5.1 Following their appointment, the Joint Liquidators considered the information acquired in the course of appraising and realising the business and assets of the Company, together with information provided by the Company's directors and its creditors, to identify any further possible realisations for the estate and what further investigations, if any, might be appropriate.
- 5.2 That assessment did not identify any possible further realisations. In addition, the Joint Liquidators concluded that no further investigations were required. If, however, any creditor is aware of any particular matters which they consider require investigation, they should send full details to this office.
- 5.3 Notwithstanding the above, the Joint Liquidators have complied with their statutory obligations under the Company Directors Disqualification Act 1986 and the appropriate report has been submitted to the relevant authority.

6 JOINT LIQUIDATORS' REMUNERATION, EXPENSES AND DISBURSEMENTS, AND CREDITORS' RIGHTS

Remuneration

- A fee of £7,500 for the preparation of the statement of affairs was approved by creditors on 27 February 2019. £3,500 has been drawn, £1,500 of which has been paid to Davenport Hodgkiss for their assistance with the preparation of the statement of affairs.
- 6.2 No resolution was proposed to creditors in respect of the Joint Liquidators' remuneration. Based on present information, the Company has sufficient assets to enable the payment of any Joint Liquidators' remuneration from the estate and a fee resolution report will be circulated to creditors in due course.

Expenses and Disbursements

- A summary of the Joint Liquidators' expenses from 27 February 2019 to 26 February 2020 is attached at Appendix B. To assist creditors' understanding of this information, it has been separated into the following two categories:
 - Standard Expenses: this category includes expenses payable by virtue of the nature of the Liquidation process and / or payable in order to comply with legal or regulatory requirements.
 - Case Specific Expenses: this category includes expenses likely to be payable by the Joint
 Liquidators in carrying out their duties in dealing with issues arising in this particular Liquidation.
 Included within this category are costs that are directly referable to the Liquidation but are not
 paid to an independent third party (and which may include an element of allocated costs). These
 are known as 'category 2 disbursements' and they may not be drawn without creditor approval.
- 6.4 No resolution has yet been proposed to creditors with regard to the Joint Liquidators' category 2 disbursements.
- Attached at Appendix C is additional information in relation to the firm's policy on staffing, the use of subcontractors, disbursements and details of current charge-out rates by staff grade. Please be aware that the firm's charge out rates have been amended with effect from 1 August 2019.
- 6.6 During the Liquidation, the following professional advisors and / or subcontractors have been used:

- The Joint Liquidators instructed Cerberus to provide an independent valuation of the assets due to their increased knowledge and expertise in this area.
- Davenport Hodgkiss were instructed to assist with the statement of affairs due to their prior knowledge of the Company's finances.

Creditors' Rights

6.9 Under Rule 18.9 of the Rules, within 21 days of receipt of this report, a secured creditor, or an unsecured creditor with either the concurrence of at least five per cent in value of the unsecured creditors (including the creditor in question), or with the permission of the court, may request in writing that the Joint Liquidators provide further information about their remuneration or expenses which have been itemised in this report.

- Under Rule 18.34 of the Rules, any secured creditor, or any unsecured creditor with either the concurrence of at least 10 per cent in value of the unsecured creditors (including that creditor), or the permission of the court, may within eight weeks of receipt of the progress report that first reports the fee basis, the charging of the remuneration or the incurring of the expenses in question, make an application to court on the grounds that, in all the circumstances, the basis fixed for the Joint Liquidators' remuneration is inappropriate and/or the remuneration charged or the expenses incurred by the Joint Liquidators, as set out in the progress report, are excessive.
- 6.11 Unless the court orders otherwise, the costs of the application shall be paid by the applicant and are not payable as an expense of the Liquidation.

Disbursements

Information we collect and hold about you

By requesting details of your claim in this insolvency, we may collect Personal Data from you, particularly if you are a consumer creditor, a sole trader or are lodging a claim in your personal capacity.

Personal Data is information relating to a living individual. Whenever Personal Data is processed, collected, recorded, stored or disposed of it must be done within the terms of the General Data Protection Regulation ("the GDPR"). Examples of Personal Data include but may not be limited to your name, address, telephone number and email contact details.

If you do not provide us with the information we require, this may adversely affect our ability to deal with your claim, but we would ask you not to submit more Personal Data than we request from you.

Legal justification for processing your Personal Data

How we use your information
