1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Turnover

Turnover represents net invoiced sales of goods, excluding value added tax.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Office equipment - 25% on reducing balance

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the profit and loss account on a straight line basis over the period of the lease.

Going concern

Despite the company showing net liabilities, the financial statements have been prepared on a going concern basis. The director will continue to support the company for a period in excess of twelve months from the date of approval of these financial statements.

4. DIRECTOR'S ADVANCES, CREDITS AND GUARANTEES

During the year under review the company made advances to the sole director, Mr I Thirsk, amounting to £19,305 (2013 - £400).

Against this amount, Mr Thirsk made credits totalling £94,757 (2013 - £14,350). This includes £nil (2013 - £nil) in respect of dividends.

At the Balance Sheet date, the company owed Mr Thirsk £92,847 (2013 - £17,395). This is included within other creditors.

There are no conditions attached to this loan, however the director will ensure that repayment will not be detrimental to the company.
