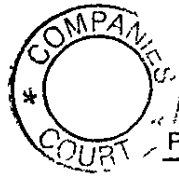

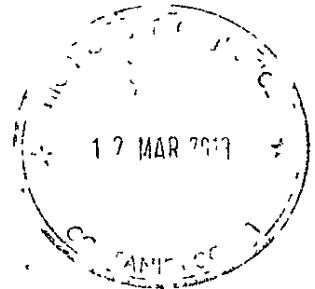
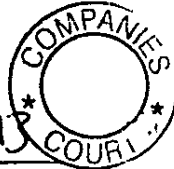

AND UPON HEARING SOLICITORS for the Petitioner

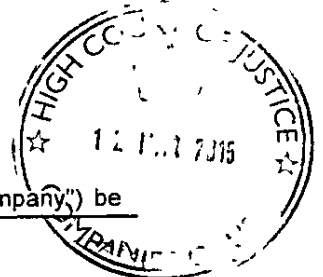
AND UPON READING the evidence

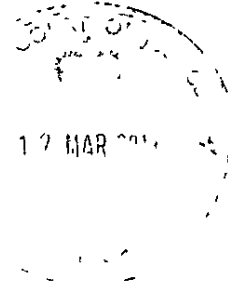

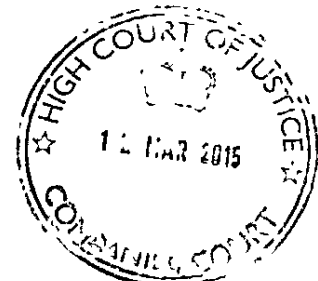
