1 Statutory Information

- 1 1 The registered number of James & James Trading Limited T/A Right Price Furniture ("the Company") is 05484484
- 1 2 The trading address of the Company is Harts Building, Main Avenue, Brackla Industrial Estate, Bridgend, Mid Glamorgan, CF31 2AG The business trades under the name Right Price Furniture
- 1 3 The registered office of the Company has been changed from HHPG House, City Road, Bridgend CF31 1LR to c/o Fisher Partners, Acre House, 11/15 William Road, London NW1 3ER
- 1 4 Details of the Company's directors and secretary are as follows

2 Background to the Administration

- 2 1 A background of the administration was provided within the Joint Administrators' initial circular to creditors dated 13 December 2010
- 2 2 The Company was a national retailer of furniture, with the majority of its orders being received through its website and by telephone
- 2 3 In November 2010, the Company was severely effected by a major supplier refusing to supply the Company and a fire at the Company's haulier's storage facility

- 2 4 The directors attempted to source new suppliers but were unsuccessful. The further disruption to the supply chain caused by the fire led to the Company being unable to fulfill orders, which had been paid in full by customers
- 2 5 The Company submitted an insurance claim in respect of the goods lost in the fire. The Company was unable to fund the purchase of replacement goods, for those lost in the fire, until the insurance money was received. As this would take many months the directors had no option but to cease trading and seek insolvency advice
- 2 6 Formal insolvency advice was then sought from Fisher Partners
- 2 7 As a result, David Birne and Brian Johnson of Fisher Partners, Acre House, 11/15 William Road, London, NW1 3ER, licensed insolvency practitioners, were appointed Joint Administrators of the Company by the directors on 10 December 2010
- 2 8 The Administration is registered in the High Court of Justice, under reference number 9941 of 2010
- 2 9 The EC Regulation on Insolvency Proceedings 2000 applies to the Administration. The proceedings are main proceedings as defined by Article 3 of the Regulation. The Company is based in the United Kingdom

3 Administration Strategy and Objective

- 3 1 The Joint Administrators must perform their functions with the purpose of achieving one of the following objectives
- rescuing the Company as a going concern,
 - achieving a better result for the Company's creditors as a whole than would be likely if the Company were wound up (without first being in Administration), or
 - realising property in order to make a distribution to one or more secured or preferential creditors
- 3 2 Due to the Company's financial position, it is not possible to rescue the Company as a going concern

- 3 3 The second objective of achieving a better result for the Company's creditors as a whole than would be likely if the Company were wound up (without first being in Administration), is being pursued by the Joint Administrators
- 3 4 As stated in the Joint Administrators' initial letter to creditors of 13 December 2010, a pre-packaged sale of various assets was completed on 10 December 2010 to J B Global Limited As far as the Joint Administrators are aware, J B Global Limited are not related to the Company
- 3 5 The sale has meant that the Company's goodwill has been realised and the overall level of realisations greater than that anticipated in a liquidation No realisations would be expected from the Company's goodwill in a liquidation The administration also allowed urgent attention to be given to the Company's potential insurance claim, which has arisen as a result of the fire at the Company's haulier's storage facility - (see later in report) As part of the sale, there is also an obligation on the purchaser to deliver certain goods to customers where the whole completed order was held If good are not required they will be sold and the proceeds split between the purchaser and the Joint Administrators This means that the Joint Administrators' costs to deliver or continue to operate the premises to allow collection of these items have been reduced
- 3 6 As you will see from the estimated outcome statement, the secured creditor is expected to be paid in full and preferential creditors are expected to receive a dividend (subject to insurance claim) As a result, the third objective, of realising property in order to make a distribution to one or more secured or preferential creditors, is also expected to be achieved
- 3 7 The secured creditor has confirmed that they are owed £2,686 07, which is anticipated to be paid within the next three to four weeks The timing and quantum of any dividend to preferential creditors is dependent on the insurance claim
- 3 8 Following the completion of the pre-packaged sale of the Company's business and assets on 10 December 2010 to J B Global Limited, the Joint Administrators sent a letter to creditors on 13 December 2010 to provide information on the sale pursuant to the requirements of Statement of Insolvency Practice No 16 Due to the significant number of customers who have paid for goods a helpline was set up to assist the customers If you wish to receive a further copy of this letter please contact our helpline on 0844 854 9160 Calls from BT landlines are charged at 5p plus VAT per minute For costs from a mobile, please check with your service provider

4 Administrators' Receipts and Payments

- 4 1 A summary of receipts and payments for the Administration period from the date of my appointment to 7 January 2011, is attached, as Appendix A
- 4 2 Please note that on advice of our agent, Edward Symmons LLP , the Company's office equipment has been abandoned by the Joint Administrators

5 Financial Position

- 5 1 Attached, at Appendix B, is a summary of the Directors' Estimated Statement of Affairs of the Company as at the date of the appointment of the Administrators
- 5 2 I have the following observations to make in relation to the Director's Estimated Statement of Affairs
- 5 3 The Statement of Affairs includes approximately 1,200 customers who have paid either part or fully for goods, which have not been received There are an additional 109 customers who have fully paid for their goods and the completed order was held by the Company If these goods are accepted by the customers, the amount owed to these creditors will be reduced accordingly
- 5 4 The outcome of the insurance claim is uncertain as detailed later in this report

6 Proposals

It is proposed that the Administrators will continue to manage the affairs of the Company in order to achieve the objective of the Administration In the circumstances it is proposed that

- 6 1 If, having realised the assets of the Company, the Joint Administrators think that a distribution will be made to the unsecured creditors, they propose filing a notice with the Registrar of Companies, which will have the effect of bringing the appointment of the Joint Administrators to an end and will move the Company automatically into Creditors' Voluntary Liquidation ("CVL") in order that the distribution can be made In these circumstances, it is proposed that the Joint Administrators will become the Joint Liquidators of the CVL

- 6 2 If the Joint Administrators think that the Company has no property, which might permit a distribution to its creditors, they will file a notice with the Court and the Registrar of Companies for the dissolution of the Company
- 6 3 The Joint Administrators shall do all such other things and generally exercise all of their powers as contained in Schedule 1 of the Insolvency Act 1986, as they consider desirable or expedient to achieve the statutory purpose of the Administration
- 6 4 The creditors consider establishing a Creditors' Committee and that if any such Committee is formed they be authorised to sanction the basis of the Joint Administrators' remuneration and disbursements and any proposed act on the part of the Administrators, without the need to report back to a further meeting of creditors generally, to include any decision regarding the most appropriate exit route from the Administration
- 6 5 Where no Creditors' Committee is appointed, the remuneration of the Joint Administrators shall be fixed by resolution of a meeting of creditors or where the Joint Administrators think that the company has insufficient property to enable a distribution to be made to the unsecured creditors (other than via the prescribed part), approval will be sought from the secured and (if necessary) the preferential creditors, in accordance with R2 106 of the Insolvency Rules 1986
- 6 6 In this case, the Joint Administrators are seeking approval for the basis of their remuneration as follows
- By reference to the time property spent by the Joint Administrators and their staff in attending to matters arising in the Administration
- 6 7 Where no creditors committee is appointed, the Joint Administrators be authorised to draw remuneration as and when funds are available
- 6 8 In accordance with Statement of Insolvency Practice No 9, issued by the Association of Business Recovery Professionals, the Joint Administrators be authorised to draw Category 2 disbursements as and when funds are available, in accordance with their firm's published tariff Details of Category 2 disbursements charged by the firm can be found in Appendix D
- 6 9 The Joint Administrators be authorised to draw the balance of their time costs incurred prior to their appointment, totalling £19,506 75

6 10 The Joint Administrators will be discharged from liability under Paragraph 98 of Schedule B1 to the Insolvency Act 1986 immediately upon their appointment as Joint Administrators ceasing to have effect

7 Exit Routes

Creditors Voluntary Liquidation

- 7 1 The prospects and level of any dividend to unsecured creditors is dependent on the outcome of the insurance claim If any dividend is payable to the unsecured creditors, the Joint Administrators will file a notice with the Registrar of Companies in order that the Administration will cease and the Company will move automatically into Creditors' Voluntary Liquidation ("CVL") It is proposed that the Joint Administrators will also become the Joint Liquidators of the CVL
- 7 2 Creditors have the right to nominate an alternative liquidator of their choice To do this, creditors must make their nomination in writing to the Joint Administrators prior to these proposals being approved Where this occurs, the Joint Administrators will advise creditors and provide the opportunity to vote In the absence of a nomination, the Joint Administrators will automatically become the Joint Liquidators of the subsequent CVL

8 Pre-administration Costs

Pre-administration costs are defined as

- (i) Fees charged, and
- (ii) Expenses incurred

by the Administrators, or another person qualified to act as an insolvency practitioner before the company entered Administration (but with a view to its doing so), and "unpaid pre-administration costs" are pre-administration costs which had not been paid when the company entered Administration

- 8 1 Following the Company approaching Fisher Partners for advice, Fisher Partners were formally instructed on 22 November 2010 It was agreed that Fisher Partners' pre-appointment fees would be on a time costs basis and the sum of £17,625, being £15,000 plus VAT, was paid on account by the Company

8 2 The time spent by Fisher Partners includes the following

- Preparation of the appointment documentation and presentation to Court.
- Negotiations in relation to the sale of the Company's assets and corresponding and liaising with agents in relation to the Company's assets
- Correspondence with the secured creditor
- Reviewing and agreement of a sale and purchase agreement for various assets
- Seeking legal advice in relation to customers' deposits, stock, retention of title claims and the potential insurance claim
- General advice and assistance in the period leading up to the Administration, including meetings with the Company's directors and ensuring the Company's records were updated to ensure a smooth running of the Administration

8 3 In total, Fisher Partners time costs leading up to the appointment of Joint Administrators were £34,506.75 Of this amount, £19,506.75 remains unpaid

8 4 In order to pursue the objectives of the Administration and ensure that completion of the sale of the Company's assets could be concluded as soon as possible after the Company entered Administration, a large amount of work had to be undertaken prior to the Administration As explained previously, the sale of various assets shortly following the Administration was expected to provide the best outcome for all classes of creditors of the Company The sale ensured that realisations were made from the Company's goodwill, which was expected to diminish the later it was sold in the Administration

8 5 In addition to the above, an independent agent and valuer, Edward Symmons LLP, was instructed to value the Company's assets, market the Company's assets and advise in relation to offers received Their costs were agreed at £5,146 plus VAT + disbursements This sum has not yet been paid

8 6 Rosenblatt Solicitors LLP provided legal assistance to the Company and Joint Administrators in relation to the preparation, agreement and execution of the asset sale and purchase agreement They also provided legal advice in relation to the stock held by the Company, which partly related to customer orders, whilst some was also subject to potential retention of title claims Legal advice was also requested in relation to the potential insurance claim, in

respect of the fire. As such, the majority of the solicitor's time costs were incurred prior to the appointment of Joint Administrators. In total, their costs are £7,000 plus disbursements of £6 for Companies House searches plus VAT. The total, being £8,232.05, has been deducted from the proceeds of the sale of the assets, with the balance having been paid to the Joint Administrators. There are no further pre-appointment legal costs, however, Rosenblatt Solicitors may be retained to complete any further legal work, as required.

- 8.7 The payment of the unpaid pre-administration costs set out above, as an expense of the Administration, is subject to the approval of creditors, separately to the approval of the Administrators' proposals. This approval will be the responsibility of the Creditors' Committee if one is appointed or alternatively by resolution of a meeting of creditors where there is no Committee.

9 Administrators' Remuneration

- 9.1 The Joint Administrators' time costs at 31 December 2010 are £16,447.75. This represents 85 hours at an average rate of £193.5 per hour. As noted in the Proposals section above, the Joint Administrators are seeking to fix the basis of their remuneration on a time costs basis. Appropriate approval will be sought as outlined in section 6 of this report.

- 9.3 Attached, as Appendix C, is a Time Analysis which provides details of the activity costs incurred by staff grade to the above date.
- 9.4 The majority of Partner time has been spent in relation to case administration, including press releases, reviewing the retention of title claims and in relation to customer issues.
- 9.5 The majority of Group Leader time has been spent in relation to attending to customer queries, case planning and in relation to the preparation of the Joint Administrators' initial report to creditors.

- 9 6 The majority of Administrator time has been spent attending to creditor queries, including calls, emails and letters to the Company's customers. Significant Administrator time has also been spent in relation to asset realisations, including reviewing retention of title claims from suppliers and in relation to the Company's insurance claim. Time has also been spent on case administration, including attendance at the Company's former trading premises.
- 9 7 Support Staff time has been spent in relation to the distribution of the Company's initial circular to creditors and circulars to customers. Time has also been spent in relation to the preparation of statutory notices and correspondence to relevant parties following the appointment of Joint Administrators.
- 9 8 Attached, as Appendix D, is additional information in relation to the Joint Administrators' firm's policy on staffing, the use of sub-contractors, disbursements and details of current charge-out rates by staff grade.

10 Estimated Outcome

- 10 1 An estimate of the outcome of the Administration as at 7 January 2011, is attached, as Appendix E. This indicates that the secured creditor is likely to be paid in full. The prospect and level of dividends to preferential creditors and unsecured creditors (which includes customers) is dependent on realisations from the insurance claim.
- 10 2 The insurance claim is complicated by the fact that the fire was at a third party premises, which may affect the level of the claim. Information provided by the Company shows that items totalling over £100,000 (at cost price) were destroyed by the fire. Our insurance adviser, AUA Insolvency Risk Services, are liaising with the broker and the loss adjuster regarding the extent of the claim. Creditors will be advised of progress in the next report.
- 10 3 Customers who have claims against the Company are advised to contact their card company to arrange a refund, where possible. Customers should note that they will not receive a full refund by submitting a claim in the Administration.
- 10 4 Based on the director's Statement of Affairs attached to this report, the estimated value of the preferential creditors is £19,855.24 (preferential creditors are employees for certain arrears of pay and holiday pay) and the unsecured creditors total £898,471.49.
- 10 5 The Company granted a debenture comprising of fixed and floating charges to National Westminster Bank plc ("Natwest") on 27 May 2010. There have been sufficient realisations

from fixed charged assets, being the goodwill, to ensure Natwest are paid in full. Accordingly, there is no requirement to create a fund out of the Company's net floating charge property for unsecured creditors.

11 Next Report

- 11 1 The Administrators is required to provide a progress report within one month of the end of the first six months of the Administration.

12 Meeting of Creditors

- 12 1 An initial meeting of the Company's creditors is being convened to approve the Administrators' proposals. The meeting will be held on 24 January 2011 at 2.30 pm at the Hilton London Euston, Stephenson Suite, 17-18 Upper Woburn Place, London WC1H 0HT.
- 12 2 Further information on the meeting is contained in the letter accompanying this report.

1.3 Disbursements
