Algrave Limited and 726 other companies - All In Administration ("the Companies")

It is now twenty four months since my appointment in respect of the Companies. In accordance with Rule 2.47 of the insolvency Rules 1986, I am now reporting the progress made in implementing the approved proposals and achieving the statutory purpose of the Administrations.

# 1 Statutory Information

The Joint Administrators are Malcolm Cohen and Antony David Nygate of BDO LLP, 55 Baker Street, London, W1U 7EU and they were appointed in respect of the Companies on 29 September 2008. Under the provisions of paragraph 100(2) of schedule B1 of the Insolvency Act 1986, the Joint Administrators carry out their functions jointly and severally and neither Joint Administrator has exclusive power to exercise any function.

The Joint Administrators were appointed by the corporate director of the Companies, pursuant to Paragraph 12 of schedule B1 of the Insolvency Act 1986. As previously advised, an application was made to the High Court of Justice to consolidate the insolvency proceedings into one Administration. This report has, therefore, been prepared on a consolidated basis. The court case number is 8407 of 2008.

The Companies' registered office is situated at 55 Baker Street, London, W1U 7EU and the registered numbers are as per the attached spreadsheet.

# 2 Receipts and Payments

I enclose, for your information, a summary of my receipts and payments to date showing a balance in hand of £3,238,066.54, which I trust is self explanatory

# 3 Accounting Information

As creditors are aware, Safe Solutions International Limited ("SSIL") arranged for the accounting information pertaining to the Companies to be brought up to date for compliance and tax return purposes but has refused to provide the information to the Joint Administrators until an agreement can be reached in respect of costs incurred in

completing the work. As previously reported, this matter is still in the hands of solicitors to resolve as the Joint Administrators and SSIL have been unable to reach any agreement.

#### 4 Book Debt Collection

As you are aware, according to the records of the companies some £594,973 was due from 14 recruitment agencies in respect of unpaid invoices. To date, £45,149.74 has been recovered and £59,649.56 has been written off.

As previously reported, solicitors have been instructed to pursue the remaining agencies, which includes the principal debtor of £488,688. The solicitors met with the principal debtor in order to try and resolve this matter, following which further information was requested by the debtor. The information was collated by SSIL and the debtor attended the solicitors' office to review the requested documentation. Following this review the debtor has advised that it will provide further information in support of its defence that the debt is not due and payable.

# 5 Investigations

I am continuing to investigate the affairs of the Companies in the period prior to Administration. A number of claims have been issued by the instructed solicitors. Due to the nature of the ongoing investigations and actions I am unable to provide any further details to creditors at this time.

### 6 Future of the Administration

The Joint Administrators' proposals agreed on 5 December 2008, stated that the Companies would exit Administration by way of Dissolution under the provisions of Paragraph 84 of Schedule B1 of the Insolvency Act 1986.

On the basis that a number of issues have not yet been resolved, the Court has granted a second 12 month extension to 28 September 2011

## 7 Prospects for Creditors

Under Section 176A of the Insolvency Act 1986, where after 15 September 2003 a company has granted to a creditor a floating charge, a proportion of the net property of the company must be made available purely for the unsecured creditors. The Companies did not grant a floating charge to any creditor after 15 September 2003 and consequently there will be no prescribed part in this Administration.

To date, I have received 6 creditor claims totalling £5,696,391 22. These claims have not been adjudicated upon for dividend purposes. Until all claims have been adjudicated upon and the investigations into the affairs of the Companies completed, I am unable to confirm either the timing or quantum of any distribution to creditors.

# 8 Joint Administrators' Remuneration

The creditors of the Companies have approved that the Joint Administrators' remuneration be fixed as a percentage of the value of the property, with which I have to



deal and this has been capped at £1,750 plus VAT inclusive of general disbursements, per company

To date, the Joint Administrators have drawn remuneration totalling £685,611.05 plus VAT.

#### 9 Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. These disbursements have been detailed below.

These disbursements have been drawn with the consent of creditors. A further £346.09 of disbursements has been incurred in respect of printing charges, courier charges and storage.

Some administrators recharge expenses for example postage, stationery, photocopying charges, telephone and fax costs, which cannot economically be recorded in respect of each specific case. Such expenses, which are apportioned to cases, require the approval of the creditors, before they can be drawn, and these are known as category 2 disbursements. The policy of BDO LLP is not to charge any category 2 disbursements.
