The following comprises my Final Report to Creditors for the period ending 10 March 2010 detailing the above arrangement, as required by Rule 1.29 of The Insolvency Rules 1986.

Under the terms of the arrangement, the company was to make monthly contributions of £1,000 for sixty months

I confirm the company failed to maintain its obligations under the terms of the arrangement and a Notice of Breach was subsequently issued on 24 April 2009.

As no response was received, I convened a meeting of creditors to ascertain how the Arrangement should continue and this took place on 26 May 2009. I confirm that creditors voted to commence Winding Up Proceedings and a copy of my Variance Report is enclosed for creditor perusal.

Following the meeting, the company made sufficient payment in order to bring the arrears back within the terms agreed with creditors. However I was advised that the company had post Arrangement debt with HM Revenue & Customs amounting to approximately £14,000 and had not submitted any Returns.

The company then failed to maintain contributions in the Arrangement and was again in default of the terms agreed with creditors

I instructed my solicitor to commence Winding Up Proceedings and I can confirm that the Order was granted on 16 December 2009. A copy of the Order is enclosed for creditor perusal.

I therefore enclose a certificate of Termination along with the Supervisor's Final Receipts and Payments Accounts of the arrangement.

I have agreed unsecured creditors claims totalling £66,953.06.

I am not in a position to be able to declare any dividend to creditors.

The Nominee's fees drawn totals £6,000 + VAT.

Supervisors fees have been calculated on the basis of time costs reasonably incurred as approved at the meeting of creditors on 23 October 2008. The Supervisor's fees incurred total £2,712 + VAT of which £844.25 & VAT have been drawn to date. This represents 19.8 hours work at an average hourly rate of £136.97. I have enclosed a SIP9 schedule for creditor perusal. The remaining balance will now be drawn.

This concludes my Final Report.
