**BEFORE** District Judge Goldberg

**UPON** considering the Application for block transfer orders under Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016

**AND UPON** reading the witness statement of Abigail Shearing dated 15th January 2019 and of Nigel Millar dated 15<sup>th</sup> January 2019.

**IT IS ORDERED THAT:**

1. The County Court cases listed in Schedules 1 to 5 to this Order be transferred to the High Court of Justice, Business and Property Courts in Leeds, Insolvency and Companies List, (ChD) solely for the purpose of making this Order.
2. Immediately upon this Order taking effect, the County Court cases listed in the Schedule to this Order be transferred back to the originating County Court.
3. Nigel Millar (the **Outgoing Office Holder**) be removed from office as Liquidator, Supervisor or Trustee (as the case may be) of the estates listed in the Schedule to this Order (the **Block Transfer Cases**) and be replaced by the individuals named in the Schedule (the **New Office Holders**) as set out therein, with immediate effect. In the case of Michael Joseph Newman and Maria Jones O'Reilly, Steven Law will remain as sole Trustee.
4. Nigel Millar be removed from office in respect of the Block Transfer Cases listed in the Schedule from the date of this Order pursuant to Rule 12.37(2) of the Insolvency Rules 2016 (the **Rules**) and without being required to (i) use one of the decision procedures or deemed consent procedures set out in the rules for the insolvency cases listed in the Schedule, (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
5. Where the appointments referred to in this Order are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
6. The Outgoing Office Holder shall file a copy of this Order with each of the Courts listed in the Schedule to this Order.

7. The Creditors in each of the cases listed in Schedules 1, 2, 4 and 5 shall be notified of one composite notice ("the Advertisement") to be published in the Gazette within 14 days of receipt of the sealed Order. The Creditors in each of the cases listed in Schedule 3 shall be notified in writing of the Order within the same period.
8. The Respondents shall file any appropriate notice in respect of the removal of the Outgoing Office Holder and the appointment of the New Office Holders pursuant to paragraphs 2 and 3 of this Order with the Registrar of Companies and the Secretary of State for Business, Energy and Industrial Strategy (Insolvency Service) as appropriate.
9. In the case of the Administrations listed in Schedules 1 appended to this Order, the Outgoing Office Holder be released forthwith from any and all liability, past, present or future in respect of any act(s) and / or omissions in relation to his conduct as Office-Holder of the estates. Such release to take effect 21 days from the date of Advertisement, save in respect of any claim notified to the Outgoing Office Holder pursuant to the Insolvency Act 1986 and / or pursuant to such other provision as may apply on, or prior to, the notice date.
10. In the cases listed in Schedules 2, 4 and 5 inclusive, the Outgoing Office Holder be released from any and all liability past, present or future in respect of any act(s) and / or omissions in relation to his conduct as Office Holder of the estates from 21 days after the Advertisement in accordance with Paragraph 7 of this Order.
11. In the cases listed in Schedule 3, the Outgoing Office Holder be released from any and all liability past, present, or future in respect of any of the act(s) and / or omissions in relation to his conduct as Office Holder of the estates from 21 days after delivery of the notification in writing to the relevant Creditors.
12. Subject to paragraph 14 below, in the event that, as a result of the implementation of the Order RSM incurs any additional cost in respect of the administration of those estates where Nigel Millar was the office-holder (that is to say over and above those costs incurred in the ordinary course of the administration of those estates), those costs shall be borne by RSM and shall not be charged as an expense of the administration of those estates.
13. Nothing contained in paragraph 12 or 17 shall prejudice the Applicant, Respondent or New Office Holders from:

---

13.1 Charging to each individual estate the cost of obtaining an Insolvency Practitioner's licence bond in respect of that estate; and

13.2 Apportioning between the said estates equally, the cost of the composite London Gazette Advertisement to be placed under paragraph 7 above.

14 Without incurring any additional expense for any of the said estates, the relevant Applicant, Respondent or New Office Holder shall notify each creditor of this Application and Order by way of notice in the next routine report that shall be due to the creditors of each estate, such notice to contain the following matters:

14.1 An explanation of the effect of the Order;

14.2 Express reference to the liberty to apply contained in paragraph 16 below;

14.3 In the case of Administrations, Liquidations and Bankruptcies, where Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that any information which would otherwise be required to be provided under rule 3.63(5), 6.25(5), rule 7.61(5) or rule 10.77(5) (as the case may be) of the Insolvency Rules 2016 has not already been provided as part of the report, it is open to that committee to require the relevant Applicant, Respondents or New Office-Holder to provide an account of the administration of the estate, including a summary of receipts and payments;

14.4 In the case of Administrations, Liquidations and Bankruptcies where no Liquidation Committees or Creditors' Committees have been appointed, an explanation that, to the extent that such information as aforesaid has not already been provided as part of the report, it is open to any creditor to apply to court for an order that the relevant Applicant, Respondents or New Office-Holder do provide an account of the administration of the estate, including a summary of receipts and payments;

14.5 Notification that if any Applicant, Respondent or New Office-Holder has been required to provide the information referred to in sub-paragraphs 14.3 and 14.4 above, whether by a Liquidation Committee or by court order on the application of any creditor(s), the costs of any appointed office-holder of so complying will, unless there are good reasons to the contrary, be paid as an expense of the winding up or bankruptcy as the case may be;

---

- 14.6 In the case of Liquidations, notification to each creditor of his right under regulation 11(2) of the Insolvency Regulations 1994 to require the appointed office-holders to supply a statement of receipts and payments free of charge; and
- 14.7 In the case of the Voluntary Arrangements, the provision of all such information as might reasonably be required with regard to the conduct of the Voluntary Arrangement.
- 15 Where Nigel Millar is removed and replaced as Administrator and those administrations are subsequently converted into CVLs, the replacement Administrator in each case, as set out in the Schedule, shall also replace Nigel Millar as Liquidator.
- 16 Liberty to each creditor or in the case of solvent liquidations each member (insofar as it relates to the estate of which they are a creditor or member) to apply to vary or discharge this Order within 21 days of the date of this Order.
- 17 The costs of this Application (including VAT) shall be met by RSM Restructuring Advisory LLP save for the costs of the composite London Gazette Notice which will be apportioned equally between the relevant estates.
