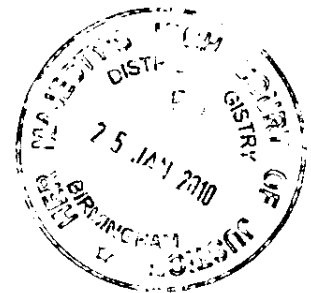

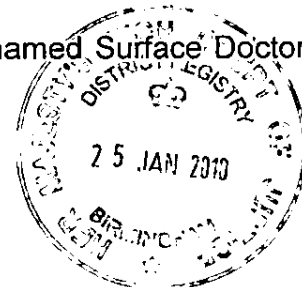

- (B) immediately upon restoration of the name of the Company to the Register of Companies take all steps necessary for procuring that the Company be placed in Members Voluntary Liquidation.



IT IS ORDERED that:


- (1) the name of the above Surface Doctor (Europe) Limited be restored to the Register of Companies
