- b serve notice of the making of this Order on all known creditors concerned in the insolvency matters identified in the Schedules hereto and stating that any creditor who is affected by this Order has permission to apply to the Birmingham District Registry of the Chancery Division to vary or discharge the same within 28 days of the date of the notice.
- 8 Lyn Marie Green be at liberty to apply in relation to obtaining her release in respect of any of the insolvency matters listed in the Schedules hereto.
- 9. The costs of this Application be provided for as follows:-
- a such remuneration, costs, or expenses in respect of this Application as are referable to a particular matter in the Schedules shall be fixed and paid in the ordinary way as remuneration, costs, or expenses in respect of such matter;
- b. such costs or expenses in respect of this Application as are not referable to a particular matter in the Schedules shall be fixed and paid in the ordinary way as remuneration, costs, or expenses and divided equally between the various matters in the Schedules and thereafter treated as costs or expenses of such matters;
- c provided that in no circumstances shall the costs payable pursuant to this Order in relation to a particular matter exceed 10% of the value of the realised assets in that matter
