Algrave Limited and 726 Other Companies ("the Companies") - All in Administration

It is now sixty-six months since my appointment in respect of the Companies. In accordance with Rule 2.47 of the insolvency Rules 1986 I am now reporting the progress made in implementing the approved proposals and achieving the statutory purpose of the administration. I have not commented on items already dealt with in previous reports and would refer you to these for further information.

#### 1 Statutory Information


The Joint Administrators are Malcolm Cohen and Antony David Nygate of BDO LLP, 55 Baker Street, London, W1U 7EU and they were appointed in respect of the above company on 29 September 2008. Under the provisions of paragraph 100(2) of Schedule B1 of the Insolvency Act 1986 the Joint Administrators carry out their functions jointly and severally and neither Joint Administrator has exclusive power to exercise any function.

The Joint Administrators were appointed by the corporate director of the Companies, pursuant to Paragraph 12 of Schedule B1 of the Insolvency Act 1986. As previously advised, an application was made to the High Court of Justice to consolidate the insolvency proceedings into one administration. This report has, therefore, been prepared on a consolidated basis. The court case number is 8407 of 2008.

The registered office of the Companies is 55 Baker Street, London, W1U 7EU and the registered numbers are listed on the attached spread sheet.

#### 2 Receipts & Payments

I enclose, for your information, a summary of my receipts and payments to date showing a balance in hand of £2,835,045.35, together with a copy of my abstract account covering the last six month period, which I trust is self-explanatory.







#### 3 Investigations

As you are aware, the Court found that Dominic Hill had breached his fiduciary duties to the Companies and that he had also caused a preference. Judgment was entered in favour of the Companies for £175,000 plus interest against.

No proposals were made to settle the debt and therefore further enforcement action was commenced. On 13 December 2012, a bankruptcy order was made against Mr Hill and at a subsequent meeting of creditors, a Trustee in Bankruptcy was appointed. The Trustee advised there were no dividend prospects for unsecured creditors. However, Mr Hill exited his bankruptcy by way of an Individual Voluntary Arrangement ("IVA") and a dividend of approximately £4k is anticipated from the IVA in due course.

#### 4 Future of the Administration

The Joint Administrators' proposals agreed on 5 December 2008 stated that the Companies would exit administration by way of dissolution under the provisions of Paragraph 84 of Schedule B1 of the Insolvency Act 1986.

As previously reported, on the basis that a number of issues had not been resolved, namely the third party claims, the Court granted a third 12 month extension to 28 September 2012. A further 18 month extension was sought and granted to enable further investigation to be carried out into the prospects of recoveries being made against SSIL and Dominic Hill. Therefore, the administrations were due to end on 28 March 2014. On 28 February 2014 the Court granted a further 12 month extension to 27 March 2015 in order to provide sufficient time to finalise the outstanding issues within the administration and make a distribution to the unsecured creditors, as detailed below.

#### 5 Prospects for Creditors

Under Section 176A of the Insolvency Act 1986, where after 15 September 2003 a company has granted to a creditor a floating charge, a proportion of the net property of the Companies must be made available purely for the unsecured creditors. The Companies did not grant a floating charge to any creditor after 15 September 2003 and consequently there will be no prescribed part in this administration.

To date, I have received four creditor claims totalling £6,648,252.39. Of these claims, one for £228,991 has been rejected and the others have not been adjudicated upon for dividend purposes. Until all claims have been adjudicated upon I am unable to confirm either the timing or quantum of any distribution to unsecured creditors. I am currently taking steps to make an application to Court that the Joint Administrators can make a distribution to this class of creditor from the administration.

As you may be aware, the Joint Administrators may not make payments by way of distribution, under Paragraph 65 of Schedule B1 of the Insolvency Act 1986, to a creditor of the Companies who is neither secured nor preferential unless the Court gives permission.

#### 6 Joint Administrators' Remuneration

The creditors of the Companies have approved that the Joint Administrators' remuneration be fixed as a percentage of the value of the property, with which I have to



deal with and this has been capped at £1,750 plus VAT inclusive of general disbursements, per company.

I can confirm that no work that is usually carried out by the Joint Administrators has been subcontracted outside my firm.

To date, the Joint Administrators have drawn remuneration totalling £1,066,848 plus VAT, for the period from 29 September 2008, the date of appointment, to 16 November 2013. Remuneration drawn to date is within the agreed cap of £1,750 per company, which totals £1,274,000 A further £39,479 has accrued since 16 November 2013 but not yet been drawn.

Attached is a schedule which summarises the time costs drawn to date and indicates the work undertaken in that respect.

#### 7 Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. These disbursements have been detailed below

These disbursements have been drawn with the consent of creditors. No further expenses have accrued.

Some administrators recharge expenses for example postage, stationery, photocopying charges, telephone and fax costs, which cannot economically be recorded in respect of each specific case. Such expenses, which are apportioned to cases, require the approval of the creditors, before they can be drawn, and these are known as category 2 disbursements. The policy of BDO LLP is not to charge any category 2 disbursements.

#### 8 Other Matters

Statement from the Insolvency Rules 1986 (as amended) regarding the rights of creditors in respect of the Joint Administrators' fees and expenses:-

#### Rule 2.48A Creditors' request for further information

- (1) If-
- (a) within 21 days of receipt of a progress report under Rule 2 47-
  - (1) a secured creditor, or
  - (ii) an unsecured creditor with the concurrence of at least 5% in value of the unsecured creditors (including the creditor in question), or
- (b) with the permission of the court upon an application made within that period of 21 days, any unsecured creditor, makes a request in writing to the administrator for further information about remuneration or expenses (other than pre-administration costs) set out in a statement required by Rule 2 47(1)(db) or (dc), the administrator must, within 14 days of receipt of the request, comply with paragraph (2).
- (2) The administrator complies with this paragraph by either-
- (a) providing all of the information asked for, or
- (b) so far as the administrator considers that-
  - (1) the time or cost of preparation of the information would be excessive, or
  - (ii) disclosure of the information would be prejudicial to the conduct of the administration or might reasonably be expected to lead to violence against any person, or
  - (iii) the administrator is subject to an obligation of confidentiality in respect of the information, giving reasons for not providing all of the information.
- (3) Any creditor, who need not be the same as the creditor who requested further information under paragraph (1), may apply to the court within 21 days of—
- (a) the giving by the administrator of reasons for not providing all of the information asked for, or
- (b) the expiry of the 14 days provided for in paragraph (1),
  - and the court may make such order as it thinks just
- (4) Without prejudice to the generality of paragraph (3), the order of the court under that paragraph may extend the period of 8 weeks provided for in Rule 2 109(1B) by such further period as the court thinks just.

#### Rule 2.109 Creditors' claim that remuneration is or other expenses are excessive

- (1) Any secured creditor, or any unsecured creditor with either the concurrence of at least 10% in value of the unsecured creditors (including that creditor) or the permission of the court, may apply to the court for one or more of the orders in paragraph (4).
- (1A) Application may be made on the grounds that-
- (a) the remuneration charged by the administrator,
- (b) the basis fixed for the administrator's remuneration under Rule 2 106, or
- (c) expenses incurred by the administrator,
  - is or are, in all the circumstances, excessive or, in the case of an application under sub-paragraph (b), inappropriate.
- (1B) The application must, subject to any order of the court under Rule 2 48A(4), be made no later than 8 weeks after receipt by the applicant of the progress report which first reports the charging of the remuneration or the incurring of the expenses in question ("the relevant report").
- (2) The court may, if it thinks that no sufficient cause is shown for a reduction, dismiss it without a hearing but it shall not do so without giving the applicant at least 5 business days' notice, upon receipt of which the applicant may require the court to list the application for a without notice hearing. If the application is not dismissed, the court shall fix a venue for it to be heard, and give notice to the applicant accordingly.



Statement from the Insolvency Rules 1986 (as amended) regarding the rights of creditors in respect of the Joint Administrators' fees and expenses (continued):-

#### Rule 2.109 (continued)

- (3) The applicant shall, at least 14 days before the hearing, send to the administrator a notice stating the venue and accompanied by a copy of the application, and of any evidence which the applicant intends to adduce in support of it.
- (4) If the court considers the application to be well-founded, it must make one or more of the following orders—
- (a) an order reducing the amount of remuneration which the administrator was entitled to charge,
- (b) an order fixing the basis of remuneration at a reduced rate or amount,
- (c) an order changing the basis of remuneration,
- (d) an order that some or all of the remuneration or expenses in question be treated as not being expenses of the administration.
- (e) an order that the administrator or the administrator's personal representative pay to the company the amount of the excess of remuneration or expenses or such part of the excess as the court may specify,

and may make any other order that it thinks just, but an order under sub-paragraph (b) or (c) may be made only in respect of penods after the penod covered by the relevant report

(5) Unless the court orders otherwise, the costs of the application shall be paid by the applicant, and are not payable as an expense of the administration
