Book Debts

The sum of £262.03 has been recovered in respect of the company's debtor ledger. It has come to light that an additional sum may be due from an associated company. We are currently in the process of investigating this matter.

Bank Account

The credit balance of £39.18 contained in the company's bank account has been received.

CREDITOR CLAIMS

No preferential claims have been received during the course of our administration.

Non preferential claims agreed to date total £27,688.68 and have been lodged by two creditors.

INVESTIGATION

The Joint Administrators have now concluded their investigations into the trading activities of the company prior to the cessation of trade. The Joint Administrators have instructed solicitor's to pursue the former director in relation to an overdrawn Director's Loan Account.

The Joint Administrators have complied with the Company Directors Disqualification Act and lodged a report of the directors' conduct with the Department for Business, Enterprise & Regulatory Reform. The contents of this report however are confidential between the Insolvency Practitioner and the Secretary of State.

REMUNERATION

You will see from the enclosed receipts and payments account that it has not been possible to draw any remuneration in the period since our appointment. The resolution passed at the creditors meeting held on 8th April 2009 provided for remuneration to be based on the time costs of the Joint Administrators and their staff, with authority to draw fees on account.
