

1 Introduction and Statutory Information

- 1.1 I, Alan Fallows, together with my partner Peter James Anderson, of Kay Johnson Gee Corporate Recovery Limited, 1 City Road East, Manchester, M15 4PN, was appointed as Joint Liquidator of Acumen Fieldwork Limited (the **Company**) on 21 February 2017. This report provides an update on the progress in the liquidation for year ended 20 February 2019 (**the Period**).
- 1.2 Information about the way that we will use, and store personal data on insolvency appointments can be found at www.kjgcr.com/privacy-policy. If you are unable to download this, please contact us and a hard copy will be provided to you.
- 1.3 The trading address of the Company was 3 Canal Street, The Village, Manchester, M1 3HE. The business traded under the name Acumen Fieldwork Limited and its registered number is 05584241.

2 Progress of the Liquidation

- 2.1 At Appendix A, I have provided an account of my Receipts and Payments for the Period, with a comparison to the Declaration of Solvency values together with a cumulative account since my appointment.

Debtors

- 2.2 The Company's debtors have been realised in full by the Company and were remitted to the Company's bank account.

Cash at bank

- 2.3 The Company discharged known trade creditors and the balance of funds remaining was remitted to this office.

Bank interest

- 2.4 Bank interest of £15.58 has been received.

3 Creditors' Claims

Secured Creditors

- 3.1 There are no secured creditors.

Preferential Creditors

- 3.2 A summary of preferential claims is detailed below:

- 3.3 Preferential creditors were paid in full together with statutory interest on 14 September 2017.

Unsecured Creditors

- 3.4 I have received claims totalling £17,829.32 from 2 creditors, this includes a provisional claim from HM Revenue & Customs ("HMRC"). The Directors have made a Declaration of Solvency

to the effect that all of the Company's debts will be paid in full, together with statutory interest, within 12 months of the commencement of the Liquidation.

- 3.5 There is currently an ongoing investigation by HMRC into the Company's remuneration trust arrangements. HMRC have raised determinations that have been appealed by this office. The determinations relate to the tax years 2013-2014, 2014-2015, 2015-2016 and 2016-2017.
- 3.6 This matter is still ongoing and as such a dividend is unable to be paid as HMRC's claim cannot be quantified.

4 Distributions to Members

- 4.1 A distribution in specie was declared of £15,155.45 on 17 May 2017.

5 Joint Liquidators' Remuneration

- 5.1 The members approved that the basis of the Liquidators' remuneration be fixed as a set amount of £3,000 plus VAT, which has been discharged.
- 5.2 Attached as Appendix B is additional information in relation to the Liquidators' fees.

8 Next Report

- 8.1 I am required to provide a further report on the progress of the liquidation within two months of the end of the second anniversary of the liquidation, unless I have concluded matters prior to this, in which case I will write again with my proposed final account.



Appendix B

Additional Information in Relation to Joint Liquidators' Fees

9 Staff allocation and the use of subcontractors

- 9.1 The general approach to resourcing our assignments is to allocate staff with the skills and experience to meet the specific requirements of the case.
- 9.2 The constitution of the case team will usually consist of a Partner, a Manager, and an Administrator or Assistant. The exact constitution of the case team will depend on the anticipated size and complexity of the assignment and the experience requirements of the assignment.
