Algrave Limited and 726 Other Companies ("the Companies") - All in Administration

It is now fifty-four months since my appointment in respect of the Companies. Herein follows a report on the progress made in implementing the approved proposals and achieving the statutory purpose of the Administration for the period to 28 March 2013.

1 Statutory Information

The Joint Administrators are Malcolm Cohen and Antony David Nygate of BDO LLP, 55 Baker Street, London, W1U 7EU and they were appointed in respect of the Companies on 29 September 2008. Under the provisions of paragraph 100(2) of schedule B1 of the Insolvency Act 1986, the Joint Administrators carry out their functions jointly and severally and neither Joint Administrator has exclusive power to exercise any function.

The Joint Administrators were appointed by the corporate director of the Companies, pursuant to Paragraph 12 of Schedule B1 of the Insolvency Act 1986. As previously advised, an application was made to the High Court of Justice to consolidate the insolvency proceedings into one Administration. This report has, therefore, been prepared on a consolidated basis. The court case number is 8407 of 2008.

The registered office of the Companies is 55 Baker Street, London, W1U 7EU and the registered numbers are listed on the attached spreadsheet.

2 Receipts & Payments

I enclose, for your information, a summary of my receipts and payments to date showing a balance in hand of £2,910,756.08, together with a copy of my abstract account covering the last six month period, which I trust is self-explanatory

3 Accounting Information

As creditors are aware, Safe Solutions International Limited ("SSIL") arranged for the accounting information pertaining to the Companies to be brought up to date for compliance and tax return purposes, but had refused to provide the information to the Joint Administrators until an agreement could be reached in respect of costs incurred in





completing the work. According to the records maintained at Companies House, SSIL was dissolved on 25 October 2011 and the Joint Administrators restored the company to the register on 12 April 2012 in order to commence litigation against SSIL in respect of a separate matter. No agreement was reached with SSIL and the Official Receiver is the Liquidator of SSIL.

4 Book Debt Collection

As you are aware, according to the records of the Companies some £594,973 was due from 14 recruitment agencies in respect of unpaid VAT on invoices. To date, £45,149.74 has been recovered.

Solicitors were instructed to pursue the remaining agencies including the principal debtor that according to the records of the Companies owed £488,688 Following a number of meetings with the debtor together with HM Revenue & Customs in order to try and resolve the matter, the Joint Administrators have concluded that the debt is not in fact due. This has been confirmed by HM Revenue & Customs

The remaining debts of £61,135 26 have been written off.

5 Investigations

As previously reported, the Joint Administrators had instructed solicitors to instigate legal proceedings against a number of third parties. The claims made by the Joint Administrators have now been heard before the High of Court of Justice and judgment has been handed down

The claims brought by the Joint Administrators were:

- that the sum of £375,000 received by SSIL from the Companies between 16 November 2007 and 9 June 2008 was a voidable preference within the meaning of Section 239 Insolvency Act 1986; and
- that the payment of £375,000 which Mr Dominic Hill allowed to be made by the Companies to SSIL was a breach of his fiduciary duties to the Companies and was therefore misfeasance within the meaning of section 212 insolvency Act 1986.

SSIL and Dominic Hill ("the Respondents") asserted that £200,000 was held in trust for them in respect of interest that had accrued on accounts in the names of the Companies prior to Administration. Under the terms of the management agreement between SSIL and the Companies, it was alleged that the moment any interest accrued on the relevant bank accounts the interest was deemed to belong to SSIL.

The Court, in delivering the judgment, found that the monies were held on trust for SSIL and therefore ordered that the sum be set off against the sums claimed by the Joint Administrators.

With regards to the remaining £175,000, the Court found that Dominic Hill had breached his fiduciary duties to the Companies and that he had also caused a preference to be made to SSIL. Judgment was entered in favour of the Companies for £175,000 plus interest against both of the Respondents.



Following the judgment, solicitors were instructed to recover the sums due from both SSIL and Dominic Hill:

- In relation to SSIL, a winding up petition was heard in the High Court on 20
 August 2012, following which the Official Receiver was appointed liquidator.
 Unfortunately, SSIL has no assets that the liquidator could realise and so there will be no recovery to the Administrations from SSIL.
- In relation to Dominic Hill, no proposals were made to settle the debt and
 therefore further enforcement action was commenced. On 13 December 2012, a
 bankruptcy order was made against Mr Hill and at a subsequent meeting of
 creditors, a Trustee in Bankruptcy was appointed. It is likely to be another 2-3
 months before an update is provided by the Trustee and therefore I am unable to
 comment on the likelihood of any funds being returned to the Administrations.

6 Future of the Administration

The Joint Administrators' proposals agreed on 5 December 2008 stated that the Companies would exit Administration by way of dissolution under the provisions of Paragraph 84 of Schedule B1 of the Insolvency Act 1986.

As previously reported, on the basis that a number of issues had not been resolved, namely the third party claims, the Court granted a third 12 month extension to 28 September 2012. A further 18 month extension was sought and granted to enable further investigation to be carried out into the prospects of recoveries being made against SSIL and Dominic Hill Therefore, the Administrations are due to end on 28 March 2014.

7 Prospects for Creditors

Under Section 176A of the Insolvency Act 1986, where after 15 September 2003 a company has granted to a creditor a floating charge, a proportion of the net property of the company must be made available purely for the unsecured creditors. The Companies did not grant a floating charge to any creditor after 15 September 2003 and consequently there will be no prescribed part in this Administration.

To date, I have received five creditor claims totalling £5,696,391 22. These claims have not been adjudicated upon for dividend purposes. Until all claims have been adjudicated upon I am unable to confirm either the timing or quantum of any distribution to creditors. I will be taking steps to adjudicate claims following an application to Court that the Joint Administrators can make a distribution to this class of creditor from the Administrations.

As you may be aware, the Joint Administrators may not make payments by way of distribution, under Paragraph 65 of Schedule B1 of the Insolvency Act 1986, to a creditor of the Companies who is neither secured nor preferential unless the Court gives permission.



8 Joint Administrators' Remuneration

The creditors of the Companies have approved that the Joint Administrators' remuneration be fixed as a percentage of the value of the property, with which I have to deal with and this has been capped at £1,750 plus VAT inclusive of general disbursements, per company.

I can confirm that no work that is usually carned out by the Joint Administrators has been subcontracted outside my firm.

To date, the Joint Administrators have drawn remuneration totalling £1,003,537.65 plus VAT, for the period from 29 September 2008, the date of appointment, to 24 March 2012. Remuneration drawn to date is within the agreed cap of £1,750 per company, which totals £1,274,000 A further £11,754 20 has accrued since 24 March 2012 but not yet been drawn.

Attached is a schedule which summarises the time costs drawn to date and indicates the work undertaken in that respect.

9 Disbursements

Where disbursements are recovered in respect of precise sums expended to third parties there is no necessity for these costs to be authorised. These are known as category 1 disbursements. These disbursements have been detailed below.

These disbursements have been drawn with the consent of creditors.
