**NOTES TO DIRECTOR'S ESTIMATED STATEMENT OF AFFAIRS**  
**AS AT 14 MAY 2015**

- 1 The Company has Goodwill with a book value of £55,000 disclosed in its accounts However, for the purposes of the Statement of Affairs, the estimated to realise value is shown as uncertain
- 2 The Company's leasehold improvements are recorded in its accounts with a book value of £949 However, for the purposes of the Statements of Affairs, the estimated to realise value is shown as nil as the improvements are likely to be contained within the fabric of the leasehold premises and have no realisable value
- 3 The Company's Sales Ledger discloses outstanding balances totalling £1,132,943 There are a small number of bad debts contained therein, which have yet to be written off in the Company's books and records A provision for the bad debts, and for potential disputes or contra claims is included within the Statement of Affairs, which reduces the estimated to realise value of the book debts to £1,019,648
- 4 Mr Matthew Miller is owed £842,380 in respect of a loan facility provided to the Company, which was utilised to discharge its indebtedness to Lloyds Bank Commercial Finance Limited Mr Matthew Miller has been provided with security by way of fixed and floating charges over the assets of the Company, created on 24 April 2015 The relevant Charge documentation was filed at Companies House on 28 April 2015 This re-financing formed part of a potential larger investment in the Company, which did not take place
- 5 The Company's books and records disclose an asset value of £50,692 in respect of its office furniture and equipment These chattels are comprised of desks, chairs and office equipment These assets have been appraised by independent valuation agents, namely Lambert Smith Hampton ("LSH"), and their estimated to realise value is considered to be circa £1,400
- 6 The Company's books and records disclose an asset value of £3,260 in respect of its plant & machinery This is mainly comprised of sewing machines to make sample products These assets have been appraised by LSH and the estimated to realise value on a forced sale basis is considered to be circa £2,000
- 7 Stock/WIP is recorded in the Company's books and records with a book value of £445,084 The position has been reviewed by LSH and, as a result, this asset has been attributed an uncertain estimated to realise value for the purposes of the Statement of Affairs This is due to the estimated costs to complete the work, the likely transport costs, and the amounts outstanding to various factories Its realisable value will ultimately depend on the confirmation of the intended orders from the ultimate customer and confirmation of the actual costs to complete Whilst recorded as Stock/WIP, it is noted that the Company does not, and never has, held stock
- 8 The Company owns 100 shares in Elegantly Waisted Limited, which is a non-trading entity incorporated following the purchase of the Elegantly Waisted business Accordingly, for the purposes of the Statement of Affairs, it is considered that these shares are worthless and have an estimated to realise value of nil
- 9 The Company's records disclose an amount of £291,977 as being due from its Director/Shareholders For the purposes of the Statement of Affairs, an uncertain value has been placed on this for estimated to realise purposes This account will need to be reconciled by the duly appointed Liquidator to ascertain its accuracy It is currently not known whether the Director/Shareholders have the ability to repay these loans

- 10 The Company has provided its current, and former, landlord with rent deposits, understood to be in the sums of £15,200 and £32,405 respectively For the purposes of the Statement of Affairs, these deposits have an estimated to realise value of nil due to the liabilities owed to the respective landlords
- 11 The employees of the Company have claims for arrears of wages and accrued holiday pay
- 12 Lloyds Bank plc is owed approximately £23,000 in respect of its overdraft The Company granted a Fixed and Floating Charge to Lloyds on 1 October 2014 and a Fixed Charge on 4 November 2014
- 13 The employees of the Company have unsecured non-preferential claims in respect of notice pay and redundancy, together with any balance of arrears of pay that did not rank as preferential
- 14 HM Revenue & Customs is owed £39,643 in respect of unpaid VAT for the period from 1 February 2015 to date
- 15 HM Revenue & Customs is owed income tax and national insurance contributions totalling £227,288, which relates to deductions for the months of February and March 2015
- 16 The total estimated deficiency of the Company is subject to the costs and expenses of the liquidation






