AND UPON READING the evidence

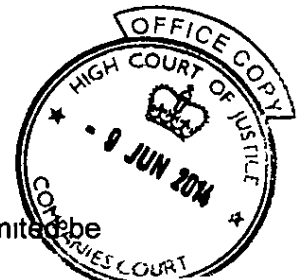
AND UPON the Official Receiver having confirmed to the Claimants' Solicitors

- (4) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (5) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (6) the Claimants do jointly and severally pay to the Registrar of Companies in the agreed sum of £300
- (7) the hearing fixed for the 11 July 2014 at 2 00 pm be vacated
