BLOCK TRANSFER ORDER

UPON the application of Richard Albert Brock Saville of Church House, 13-15 Regent Street, Nottingham NG1 5BS in October 2018 ("the Application")

AND UPON reading the documents filed including the consent of the Respondent

AND UPON the Secretary of State for Business, Energy and Industrial Strategy having been notified of the Application as required

AND UPON considering the Application on the papers filed and without a hearing

IT IS ORDERED that:

1. Each of the cases listed in the attached schedules B, D and F not already before this court be transferred to the Business and Property Courts in Birmingham for the purpose only of making this Order.
2. Immediately upon this Order taking effect, the cases listed in the attached schedules B, D and F be transferred back to the relevant court previously seized of them.
3. Richard Albert Brock Saville ("outgoing officeholder") be removed from office in respect of each of the cases in the attached schedules A to G ("block transfer cases") from the date of this Order.
4. Andrew John Cordon ("replacement officeholder") be appointed as replacement officeholder in respect of each of the cases in the attached schedules A to G, except in any case where he was already appointed joint officeholder with the Applicant where he shall henceforth be the sole officeholder.
5. The creditors in each of the block transfer cases in the attached Schedules B to G be notified of this Order by advertisement in the London Gazette (either as individual notices or one composite notice) to be published within 14 days of this order.
6. Any creditor or, in the case of the companies in members' voluntary liquidation, any member, in respect of any of the companies, persons or LLPs who has an objection to this Order shall have 28 days from the date of the advertisement referred to above to apply to court to set aside or vary the terms of this Order. Such application shall not affect the transfer of the block transfer cases until further or other order by the court and shall be made on notice to the Applicant and his solicitors.
7. The replacement officeholder shall give notice to the Secretary of State and the Registrar of Companies in respect of the administrations and liquidations scheduled and where appropriate the Insolvency Service of the terms of this Order as soon as reasonably practicable.
8. The outgoing officeholder shall file a copy of this Order with every court currently seized of any case affected by it.

9. Nothing in this Order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases specified.
10. Nothing in this Order shall affect the timing of any case progress reports under the Insolvency (England & Wales) Rules 2016.
11. The outgoing officeholder shall receive his release as administrator, liquidator, supervisor or trustee in bankruptcy 7 days after filing notice of his removal with the Registrar of Companies in respect of the companies and LLPs or the giving of notice to creditors in accordance with this Order in any other case, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6 of this Order for the specific case subject to that application.
12. The costs of the Application shall be paid as an expense and shall be apportioned equally between each of the block transfer cases so that the estate of each block transfer case shall bear an equal proportion of the costs but with no one case bearing any more than 10% of the available funds in that case.
13. Service of the Application upon the Respondent be dispensed with.
14. The Applicant and the Respondent have permission to apply to this court in relation to any matters arising from this Order.
