

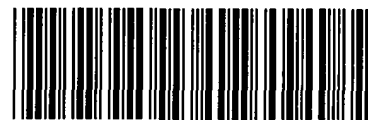

I, Emma Louise Thompson, of Smith & Williamson LLP, 25 Moorgate, London, EC2R 6AY (“the Convener”), report to the Court as follows:

Creditor approval of the CVA Proposals

At 23:59 on 14 October 2021 pursuant to Section 3 of the Insolvency Act 1986 (the “Act”) and Rules 15.3 and 15.4 of the Insolvency (England and Wales) Rules 2016 (the “Rules”), a decision of creditors was taken to approve each of the proposals for Company Voluntary Arrangements (“CVA Proposals”) that were presented to creditors in respect of each of the Companies. The CVA Proposals provided for the appointment of Finbarr Thomas O’Connell, Adam Henry Stephens and I of Smith & Williamson LLP, 25 Moorgate, London, EC2R 6AY and Andrew Stephen McGill of Smith & Williamson LLP, 3rd Floor, 9 Colmore Row, Birmingham, B3 2BJ as Joint Supervisors and that any act required or authorised under any enactment to be done by the Joint Supervisors may be done by all or any one or more of the persons holding the office of Joint Supervisor from time to time.

The Convener confirms that creditors were advised of their rights to propose any modification to the CVA Proposals.

A summary of the decisions proposed at the decision procedure and votes cast by creditors on each decision are appended at **Schedule 1** to this report. A further detailed list of creditor votes cast in respect of each of the CVA Proposals is appended at **Schedule 2** to this report.

In accordance with Rule 15.34 of the Rules the requisite majority to approve the Creditors’ Decision Procedures is a majority of three-quarters (or more) in value of creditors voting on each Creditors’ Decision Procedure, provided that not more than half of the total value of the unconnected creditors vote against each Creditors’ Decision Procedure.

The CVA Proposals of each of the 14 Companies were duly approved by creditors.

A summary of the decisions proposed at the decision procedure and votes cast by creditors on each decision are appended at **Schedule 1** to this report. A further detailed list of all creditor votes cast in respect of each of the CVA Proposals is appended at **Schedule 2** to this report.

Shareholders’ approval of the CVA Proposals

The Convener confirms that pursuant to Section 3 of the Act, voting shareholders of each of the Companies were invited to approve the CVA Proposals by way of shareholders’ written resolutions.

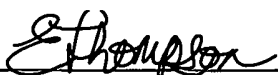

EU Regulation

These proceedings are Centre of Main Interests (“CoMI”) proceedings to which the EU Regulation, as it has effect in the law of the United Kingdom, applies.

In the matter of the above listed Companies, no modifications were approved, however, an updated version of Schedule 19 (*Reorganisation Plan*) to the CVA Proposals was provided to creditors on 11 October 2021, removing reference to some historical transactional steps that were no longer applicable to the proposed restructuring.
