Preliminary matters

- 1. The Application be listed for urgent hearing pursuant to Rule 7.4(6).
- 2. Service of the Application on the Respondent's (save for the Fourth Respondent) be dispensed with.

Discharge as administrator

In relation to the creditors' voluntary liquidations set out at Schedule B hereto to which Rule 4.49C applies, pursuant to Rule 4.3 of the Rules, the prescribed period under Rule 4.49C-CVL (7) of the Rules be extended to the end of five months after the end of the period to be covered by the subsequent progress report under Rule 4.49C-CVL(3) of the Rules. Where a Final Progress Report has been issued prior to the date of the order there shall be no requirement to file a further progress report.
- 41. In relation to the creditors' voluntary liquidations set out in Schedule B hereto to which Rule 4.49°C of the Rules does not apply there be an extension of time for the filing of any further applicable progress report so that so that any such progress report in relation to such creditors' voluntary liquidation cases will be filed 4 months from the date of the Order. Where a Final Progress Report has been issued prior to the date of the Order there shall be no requirement to file a further progress report.
- 42. In relation to the compulsory liquidations set out at Schedule C hereto to which Rule 4.49B applies, pursuant to Rule 4.49B (8) and Rule 4.3 of the Rules, the prescribed period under Rule 4.49B (7) of the Rules be extended to the end of five months after the end of the period to be covered by the subsequent progress report under Rule 4.49B(5) of the Rules. Where a Final Progress Report has been issued prior to the date of the order there shall be no requirement to file a further progress report.
- 43. In relation to the compulsory liquidations set out in Schedule C hereto to which Rule 4.49B of the Rules does not apply there be an extension of time for the filing of any further applicable progress report so that any such progress reportain 70W relation to such compulsory liquidation cases will be filed 4 months from the date

- of the Order. Where a Final Progress Report has been issued prior to the date of the Order there shall be no requirement to file a further progress report.
- 44. In relation to the administration set out at Schedule D hereto, pursuant to Rule 2.47(5) of the Rules and paragraph 107 of Schedule B1, the prescribed period under Rule 2.47(4) of the Rules be extended to the end of four months after the end of the period to be covered by the subsequent progress report under Rule 2.47(3A) of the Rules. Costs

- 45. Kingston Smith & Partners LLP to bear the costs of and occasioned by the application, save in so far as the creditors of any of the insolvent estates identified in the Schedules agree that the costs or any proportion of those costs should fall upon the insolvent estate pertaining to them.
