# NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2022

# 1 STATUTORY INFORMATION

The Elstons Residents Association Limited is a private company, limited by shares, registered in England & Wales. The company's registered number is 05795787 and registered office address is located at Unit 8 The Forum, Minerva Business Park, Lynchwood, Peterborough, PE2 6FT.

### 2 ACCOUNTING POLICIES

#### Basis of preparing the financial statements

These financial statements have been prepared in accordance with the provisions of Section 1A "Small Entities" of Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### 3 ULTIMATE CONTROLLING PARTY

Annington Nominees Limited, a company incorporated in Great Britain, is the immediate parent company. The directors regard Terra Firma Holdings Limited, a company registered in Guernsey, as the ultimate parent entity. The ultimate controlling party is Guy Hands. Annington Limited is the parent company of the largest and smallest group of which the Company is a member and for which group financial statements are drawn up. Group accounts for this company are available on request from the registered office at 1 James Street, London W1U 1DR.

# 4 ACCOUNTING POLICY

In line with RICS (Royal Institute of Chartered Surveyors) guidance on accounting for service charge income, dormant accounts have been prepared for the financial period ending 31 March 2022.

As the service charge fund is held in trust for the contributors to the fund, it is not a part of the assets of the residents association and should not therefore be shown in the balance sheet. Equally the income and expenditure relates to the fund and not to the residents association, therefore dormant accounts are applicable.

Income and expenditure into and out of the service charge fund for the accounting period is fully disclosed in the audited service charge accounts.
