The director presents the report with the financial statements of the company for the period ended 31st May 2010.


**Directors:** The director, Simon Paul Jehu held office during the whole of the period from 1st June 2009 to 31st May 2010.

The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.


