UPON THE APPLICATION of Investec Asset Finance plc presented to the court on 31 March 2011 (the "Application") in respect of CCG Logistics (UK) Limited (the "Company")

AND UPON HEARING Counsel for the applicant



AND UPON reading the evidence

AND UPON the Court being satisfied on the evidence before it that the EC Regulation does apply and that these proceedings are main proceedings as defined in Article 3 of the EC Regulation

IT IS ORDERED that

- 1. Time for service of the Application be abridged such that the Application can be heard forthwith.
- 2. Matthew Peter Bond and Andrew Gordon Stoneman (the "Administrators") be appointed administrators of the Company with effect from midnight (00 00am) on 21/22 March 2011
- 3 During the period for which this order is in force the affairs, business and property of the company be managed by the Administrators
- 4 All functions of the Administrators may be exercised by either one of the Administrators

5. For the avoidance of doubt

- a It is declared that each and every act of the Administrators acting as administrators of the Company, whether the act was joint or several, from midnight (00 00am) on 21/22 March 2011 until the making of this order, was a valid and effective act of the Administrators;
- b Any remuneration and expenses of the Administrators incurred on or after midnight (00 00am) 21/22 March 2011 but before the making of this order be payable as remuneration and expenses of the Administrators for the purpose of paragraph 99(3) of Schedule B1 to the Insolvency Act 1986,

- Any property of the company which was in the custody or control of Matthew Peter Bond and Andrew Gordon Stoneman immediately prior to the making of this order be treated as having passed to the custody and control of the Administrators in their capacity as administrators appointed pursuant to paragraph 2 above, subject to the statutory charge provided for in paragraph 99(3) of Schedule B1 of the Insolvency Act 1986 in respect of any former administrators' remuneration and expenses.
- 6 Pursuant to Insolvency Rule 12A 55(2), and in respect of the Administrators' former appointment as administrators of the Company (which appointment commenced on 22 March 2010), the time for filing Form 2 30B (notice of the automatic end of administration) in accordance with Rule 2.111(1) of the Insolvency Rules 1986 be extended until such time as the Administrators file and serve their final progress report in respect of the appointment made pursuant to paragraph 2 above
- 7 The costs of the Application be payable as an expense of the administration.
