NOTES TO THE ABBREVIATED ACCOUNTS for the Year Ended 31 December 2013

1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention, and in accordance with applicable UK accounting standards.

Going concern

The company has net current liabilities and net liabilities of £357,576 as at 31 December 2013. The directors have considered this and have prepared the financial statements on a going concern basis. The directors consider that the open market value of the property stock held by the company is in excess of the carrying value at 31 December 2013. The directors of Trehaven Group Limited, the ultimate parent company, have confirmed that they will continue to support the company by agreeing not to request payment of the debt due to Trehaven Group Limited until the company has sufficient resources to do so. The directors of the ultimate parent company and fellow group companies have also confirmed that they will continue to support the company financially. The directors have prepared cash flow forecasts which show that adequate cash resources will be available to meet the company's requirements for working capital and capital expenditure for at least the next twelve months.

Cash flow statement

The directors have taken advantage of the exemption in Financial Reporting Standard No 1 "Cash Flow Statements" (Revised) from including a cash flow statement in the financial statements on the grounds that the company is small.

Turnover

Turnover comprises sale of property during the year, exclusive of Value Added Tax. Sales are recognised once legal completion has taken place, which is upon completion of contracts.

Stocks

Trading properties are held at the lower of cost and net realisable value. Net realisable value is the estimated net proceeds of disposal.

Deferred tax

Full provision is made for deferred tax assets and liabilities arising from all timing differences between the recognition of gains and losses in the financial statements and recognition in the tax computation. A net deferred tax asset is recognised only if it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted. Deferred tax assets and liabilities are calculated at tax rates expected to be effective at the time the differences are expected to reverse. Deferred tax assets and liabilities are not discounted.

Other operating income

Other operating income represents rents receivable during the year, exclusive of Value Added Tax.
