

#### **ORDER**

**UPON THE APPLICATION** for a Block Transfer Order by Application Notice sealed on 9 October 2020 **AND UPON** reading the evidence

AND UPON it appearing that Paul Michael Davis (the "outgoing office-holder") is through retirement no longer able to continue in office in respect of the cases referred to in the Application and annexed to this Order as Schedule Y

AND UPON THE COURT being satisfied that it is expedient to transfer all of the cases listed in Schedule Y Part 2 in which the outgoing office-holder holds office to the Fourth Respondent in one single order

AND UPON THE COURT being satisfied that it is expedient to transfer all of the cases listed in Schedule Y Part 3 in which the outgoing office-holder holds office to the Fifth Respondent in one single order

AND UPON THE COURT being satisfied that it is expedient to transfer all of the cases listed in Schedule Y Part 4 in which the outgoing office-holder holds office to the Third Respondent in one single order

AND UPON THE COURT being satisfied that it is expedient to transfer all of the cases listed in Schedule Y Part 5 in which the outgoing office-holder holds office to the Second Respondent in one single order

#### IT IS ORDERED THAT:-

- Each of the cases listed in Schedule X (attached to this order) be transferred to the High Court
  of Justice, Chancery Division, Insolvency and Companies Court for the purpose only of making
  this order and are hereupon retransferred.
- 2. The outgoing office-holder be removed from office in respect of each of the cases listed in Parts 1 to 5 of Schedule Y (attached to this order) (the "block transfer cases") from the date of this order.
- 3. Adrian Paul Dante be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Part 2 of Schedule Y from the date of this order.

- 4. James Snowdon be appointed as joint replacement office-holder in respect of each of the block transfer cases listed in Part 3 of Schedule Y from the date of this order.
- 5. Georgina Marie Eason be appointed as replacement office-holder in respect of each of the block transfer cases listed in Part 4 of Schedule Y from the date of this order.
- 6. Michael Colin John Sanders be appointed as replacement office-holder in respect of each of the block transfer cases listed in Part 5 of Schedule Y from the date of this order.
- 7. The creditors in each of the block transfer cases listed in Schedule Y be notified of this order either by letter or by advertisement published in the London Gazette within 3 months of this order.
- 8. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in Schedule Y who has an objection to this order shall have 56 days from the date of this letter or advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedule Y until further or other order by the court.
- 9. The replacement officeholders appointed further to paragraphs 3 to 6 of this order shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations, administrations and voluntary arrangements listed in Schedule Y and any person who jointly holds office with the outgoing office-holder of the terms of this order as soon as reasonably practicable.
- 10. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedule Y.
- 11. Save in respect of any case the subject of an application under paragraph 9 of this order, the outgoing officeholder shall have his release as administrator 63 days after the relevant notification pursuant to paragraph 8 of this order.
- 12. Save as provided for in paragraph 11 of this order, the outgoing officeholder shall otherwise have his release upon application to the Secretary of State.

13. There shall be no order as to costs.
