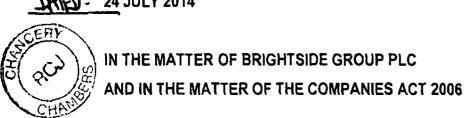

ORDER

UPON THE APPLICATION by Part 8 Claim Form dated 13 May 2014 of Brightside Group plc (the "Company") whose registered office is situated at MMT Centre, Severn Bridge, Aust, Bristol, BS35 4BL

AND UPON HEARING Counsel for the Company

AND UPON READING the said Claim Form and the evidence

THE COURT HEREBY ORDERS that the reduction of the capital of the Company resolved on and effected by a special resolution passed at a general meeting of the Company held on 16 June 2014 be and the same is hereby confirmed in accordance with the provisions of the Act

AND THE COURT HEREBY APPROVES the statement of capital set forth in Schedule 1 hereto



AND IT IS ORDERED that this Order be produced by the Company to the Registrar of Companies and that the Company deliver an office copy hereof to him together with a copy of the said statement of capital

AND THIS COURT DIRECTS pursuant to Section 650 of the Act that the Registrar of Companies do register this Order insofar as it confirms the reduction of capital of the Company notwithstanding the fact that the effect of this order is to reduce the issued share capital of the Company below the authorised minimum

AND THE COURT HEREBY approves the re-registration of the Company as a private company with the name Brightside Group Limited and directs that the articles set out in Schedule 2 hereto be the amended articles of the Company

AND IT IS ORDERED that notice of the registration by the Registrar of Companies of this Order and of the said statement of capital be published by the Company in "The Times" newspaper within 21 days after such registration
