## ORDER

---

**UPON** the Insolvency Application of the Applicant issued on 7 September 2020

**AND UPON READING** the Insolvency Application and the Applicant's Witness Statement dated 1 September 2020 and the witness statement of the Respondents dated 1 September 2020

**AND UPON** the Court considering the application on paper in accordance with rules 12.35 to 12.38 of the Insolvency Rules 2016

**IT IS ORDERED that:**

1. In respect of the insolvency appointments identified in the schedule 1 to 5 attached to this Application Notice (the “**Schedules**”) as being the subject of proceedings in the various County Courts specified in the column headed “Court” in the Schedule, those proceedings be transferred to the High Court, The Business and Property Courts in Manchester, Manchester District Registry, solely for the purpose of making the orders contained in the paragraphs below and thereafter be transferred back to the relevant County Court.
2. In respect of each creditors’ voluntary liquidation referred to in Schedule 1, the First Respondent be removed pursuant to Section 108 of the Insolvency Act 1986 (“the **Act**”) from the office of liquidator of the relevant company with immediate effect and the Applicant shall be appointed as liquidator of the relevant company in place of the First Respondent with immediate effect.
3. In respect of each members’ voluntary liquidation referred to in Schedule 2, the First Respondent be removed pursuant to Section 108 of the Act from the office of liquidator of the relevant company with immediate effect and the Applicant shall be appointed as liquidator of the relevant company in place of the First Respondent with immediate effect.
4. In respect of each company voluntary arrangement referred to in Schedule 3, the First Respondent be removed pursuant to Section 7(5) and paragraph 39(6) of Schedule A1 of the Act from the office of supervisor of the relevant company with immediate effect and the Applicant shall be appointed as supervisor of the relevant company in place of the First Respondent with immediate effect.
5. In respect of each bankruptcy estate referred to in Schedule 4, the First Respondent be removed pursuant to Section 298 of the Act from the office of trustee of the relevant bankruptcy estate with immediate effect and the Applicant shall be appointed as trustee of the relevant bankruptcy estate in place of the First Respondent with immediate effect.
6. In respect of each individual voluntary arrangement referred to in Schedule 5, the First Respondent be removed pursuant to Section 263(5) of the Act from the office of supervisor of the relevant voluntary arrangement with immediate effect and the Applicant shall be appointed as supervisor of the relevant voluntary arrangement in place of the First Respondent with immediate effect.
7. The First Respondent shall be granted her release and be discharged from liability as office-holder in respect of all appointments in the Schedules 21 days after the Order has been sealed by the Court save that such release may be subject to further order in the event of an application by any creditor under paragraph 9 of this order for the specific case subject to that application.
8. The Applicant shall, when the next routine progress report is due for service, give written notice of the making of the order, such notice to include the following matters:
  - 8.1. an explanation as to the effect of the order;
  - 8.2. express reference to the liberty to apply provision as set out in the order.
9. Liberty to each client, company and creditor in each of the insolvency appointments particularised in the Schedule to apply to vary or discharge the order within 28 days of receipt of the notice directed to be sent under Paragraph 8 above.
10. Compliance with Rule 12.38 of the Insolvency Rules 2016 is varied so that the lodging of a certified copy of the order, once sealed, with each Court is deemed to be compliant with that rule.
