#### 1 Introduction

I, Daryl Warwick of Armstrong Watson, Fairview House, Victoria Place, Carlisle, Cumbria CA1 1HP, was appointed as Joint Liquidator of A & S Robley Limited (the Company) on 11 March 2016 This report provides a summary of the outcome of the liquidation of the Company which has now been completed.

#### 2 Progress of the Liquidation

2.1 At Appendix A, I have provided an account of my Receipts and Payments for the period ended 31 August 2016 with a comparison to the Declaration of Solvency values, which provides details of the remuneration charged and expenses incurred and paid by the Liquidator during the period of this report

#### 3 Outcome for Creditors

3.1 The only creditor of the Company was a Corporation Tax liability in the sum of £1,899. I can confirm that all unsecured creditors have been paid in full, together where applicable with statutory interest

#### 4 Distributions to Members

- 4.1 The following distributions in specie have been made
  - £145,000 on 24 March 2016, and
  - £23,138 on 4 April 2016.

#### 5 Liquidator's Remuneration

The Members approved that the basis of the Liquidator's remuneration be fixed as a set amount. The Liquidator has drawn £1,500 against the total set fee agreed of £1,500 approved by Members.

#### 6 Members' Rights

- Within 21 days of the receipt of this report, members with either at least 5% of the total voting rights of all the members having the right to vote at general meetings of the Company or with the permission of the court, may request in writing that the Liquidator provide further information about his remuneration or expenses which have been itemised in this progress report.
- Any members with at least 10% of the total voting rights of all the members having the right to vote at general meetings of the Company may within 8 weeks of receipt of this progress report, make an application to court on the grounds that, in all the circumstances, the basis fixed for the Liquidator's remuneration is inappropriate and/or the remuneration charged or the expenses incurred by the Liquidator, as set out in this progress report, are excessive.
