be wound up by this Court under the provisions of the Insolvency Act 1986.

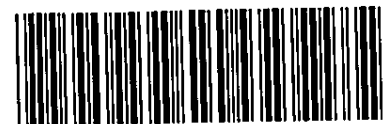
AND THE COURT being satisfied on the evidence that the EC Regulation does apply.


