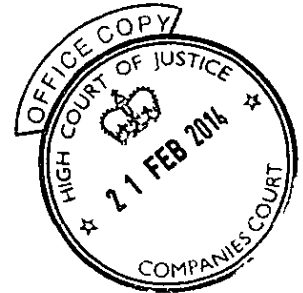

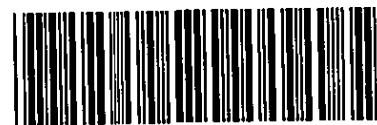

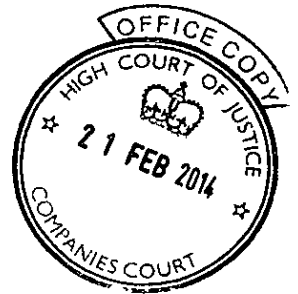
conclusion of the Claimant's claim against the company by any other means

AND UPON the Solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT

- (1) the name of the above named 06001182 Ltd be restored to the Register of Companies
- (2) the Company do continue in Compulsory Liquidation
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) in the event that the Claimant fails to comply with undertaking (B) above the Registrar of Companies be at liberty to commence strike
