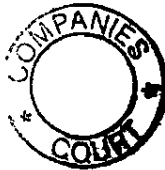

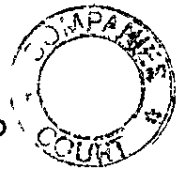
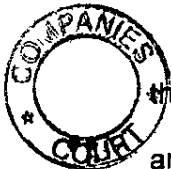

AND the Claimant by their undertaking to

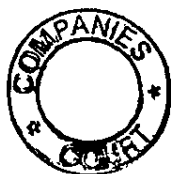
- (A) immediately upon restoration of the name of the Company to the

- (B) inform the Registrar of Companies immediately on the conclusion of the marketing and disposal of the said property by sale or on the conclusion of the Claimant's claim against the company by any other means
- (C) the Claimant will unless the action is completed in the interim, at 6 monthly intervals from the date of the Order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the action

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

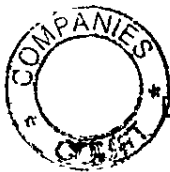
IT IS ORDERED THAT



- (1) the order made on 28 MAY 2010 be set aside
- (2) the name of the above named Bridgetown Properties Ltd be restored to the Register of Companies
- (3) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the

Companies Act 2006 change the name of the Company to 06001182  
Limited

- (4) an Office Copy of the Order be delivered to the Registrar of  
Companies and pursuant to the above mentioned Act the Company is  
thereupon to be deemed to have continued in existence as if its name  
had not been struck off
- (5) the Registrar of Companies do advertise notice of this Order in his  
official name in the "London Gazette"
- (6) the Claimant do pay to the Registrar of Companies his costs of the  
said Application in the agreed sum of £300-00
- (7) the hearing fixed for the 13<sup>th</sup> August 2010 be vacated
- (8) in the event that the Claimant fails to comply with undertaking (C)  
above the Registrar of Companies be at liberty to commence strike off  
action in respect of the Company without further notice to the Claimant
