- In relation to the appointment as administrator of the administration, the details of which appear in part 1 of the schedule annexed hereto,
 - (a) the Respondent shall be removed and replaced by the appointment of the Applicant with effect from the date of this Order and

- (b) the Respondent shall be discharged from liability pursuant to paragraph 98 of schedule B1 to the Insolvency Act 1986 ("Act") with effect from the day which falls 28 days after the appearance in the London Gazette of the advertisement referred to in paragraph 9(b) of this Order,
- In relation to all the appointments as Trustee in bankruptcy of the bankruptcies, the details of which are set out in Part 2 of the schedule annexed hereto, the Respondent shall be removed and replaced by the appointment of the Applicant with effect from the date of this Order
- In relation to all the appointments as Liquidator of the creditors' voluntary liquidations, the details of which are set out in part 3 of the schedule annexed hereto, the Respondent shall be removed and replaced by the appointment of the Applicant with effect from the date of this Order
- In relation to the appointment as Supervisor of the individual voluntary arrangement, the details of which are set out in part 4 of the schedule annexed hereto, the Respondent shall be removed and replaced by the appointment of the Applicant with effect from the date of this Order
- In relation to all the appointments as Liquidator of the members' voluntary liquidations, the details of which are set out in part 5 of the schedule annexed hereto, the Respondent shall be removed and replaced by the appointment of the Applicant with effect from the date of this Order,
- In relation to the appointment as Liquidator of the compulsory liquidation, the details of which are set out in part 6 of the schedule annexed hereto, the Respondent shall be removed and replaced by the appointment of the Applicant with effect from the date of this Order

8 In each case

- (a) the progress report required to be prepared for the purposes of Rules 2 47(3A), 4 49B(5), 4.49C(3) and 6 78A(4) of the Rules for the period which expires when this order comes into effect may be incorporated into the subsequent progress report, and
- (b) the period for sending the progress report required to be prepared for the period which expires when this order comes into effect is extended until the expiry of the period for sending the subsequent progress report
- 9. For the purpose of Rule 7 10D(6) of the Rules the Applicant is directed
 - (a) to send a sealed copy of this Order to the Secretary of State as soon as reasonably practicable
 - (b) to advertise this Order by placing a notice in the form of the draft notice contained in the first schedule to the witness statement of the Applicant in the London Gazette within [3] months of this Order and

- (c) to explain the terms of this Order in the next progress report he sends to creditors in relation to each of the insolvency proceedings
- 10 (a) The notice referred to in paragraph 9(b) of this Order shall stand as the advertisements and notices required to be gazetted, advertised and given for the purposes of section 109 and paragraph 46(2) of schedule B1 of the Act and rules 4 102, 4 103-CVL, 4 106, 4 106A, 4.118 and 4 140 of the Rules, and
 - (b) sub-paragraphs (3)(b) and (5) of paragraph 46 of schedule B1 to the Act shall not apply
- There be liberty to each creditor in the various insolvency proceedings to apply to vary or discharge this order, insofar as it relates to the particular insolvency proceeding in which that person is a creditor, within 28 days following the appearance in the London Gazette of the advertisement referred to in paragraph 9(b) of this Order
- 12 The Respondent shall be removed as a signatory on the estate bank account for each case listed and particularised in the second schedule to the witness statement of the Applicant and shall be replaced as signatory by the Applicant
- 13 The costs of and incidental to this application be summarily assessed at £3170 40 (inclusive of VAT and disbursements) such costs to be apportioned equally between the insolvency proceedings and shall be paid as an expense of such cases provided that in any case the part apportioned to that case shall not exceed 10% of the value of the realised assets of that case
