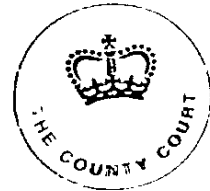

**WINDING UP ORDER**

**UPON THE APPLICATION** by Part 8 Claim Form dated 21 July 2023 of Lekoil 310 Limited (the "**Applicant**") for orders restoring Afren Nigeria Holdings Limited (the "**Company**") to the Register of Companies pursuant to sections 1029(1)(b) and 1031(1)(c) of the Companies Act 2006 (the "**Restoration Application**"), and for the compulsory winding up of the Company and the appointment of liquidators under sections 108 of the Insolvency Act 1986

**AND UPON READING** the first witness statement of Olalekan Akinyanmi dated 20 July 2023, in support of the Part 8 Claim

**AND UPON** the Court ordering the Company's name to be restored to the Register of Companies upon the consent of the Applicant and Registrar of Companies, by Order of District Judge Revere dated 7 September 2023

**AND UPON HEARING** Georgina Peters, counsel for the Applicant

**AND UPON THE COURT BEING SATISFIED** that the EU Regulation on Insolvency Proceedings (No. 848/2015) applies, as it has effect in the law of the United Kingdom, and the liquidation of the Company is a "COMI proceeding"

**IT IS ORDERED THAT:**

1. The Company be wound up by this Court under the provisions of the Insolvency Act 1986 with effect from the time and date of the sealing of this Order.

**ORDER**

**UPON** the Part 8 Claim form issued in the County Court at Central London under K80CL613 on 1 August 2023 seeking the restoration to the Register of Afren Nigeria Holdings Limited (co.no.06033276) (the "Company") (the "Claim")

**AND UPON** the claimant in the Claim being Lekoil 310 Limited of 190 Elgin Avenue, George Town, Grand Cayman KY 1-9005, Cayman Islands

**AND UPON** the order of District Judge Revere of 7 September 2023 restoring the Company to the Register and winding it up

**AND UPON** the further order of District Judge Revere of 7 September 2023 transferring the Claim to this Court for the appointment of liquidators of the Company

**AND UPON** Simon Appell, Daniel Imison and Catherine Williamson each of AlixPartners UK LLP, Ship Canal House, 8<sup>th</sup> Floor, 98 King Street, Manchester M2 4WU having between 30 November 2015 and 4 September 2021 acted as the administrators of the Company and having on the last date filed a notice of the Company's move from administration to dissolution

**AND UPON** their each having filed a consent to act as its liquidator

**AND UPON** the Court considering that an appointment may duly be made under section 140 Insolvency Act 1986

**IT IS ORDERED** that Simon Appell, Daniel Imison and Catherine Williamson be appointed as liquidators of the Company effective forthwith

**AND IT IS ORDERED** that all functions of theirs as liquidators may be carried out by all or any or some of them.

AND UPON the Claimant by their solicitors undertaking to:



- (B) within 21 days of the making of any compulsory winding up Order in respect of the Company deliver an Office Copy of that Order to the Registrar of Companies

We consent to an Order being made in the terms of the above draft restoring the name of Afren Nigeria Holdings Limited to the Register of Companies

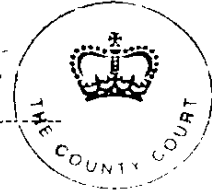
