The company is a limited partner in Folkestone Harbour Limited Partnership, a partnership set up to redevelop Folkestone harbour. Its partnership share is 11 827%. During the period, the company made an initial cash capital contribution to the partnership of £5,954,877 funded by way of loan from its parent undertaking.

Change of name

On 2nd March 2007, the company changed its name from Precis (2671) Limited to Folkestone Harbour (4) Limited

The loss for the period amounted to £329,003 and has been transferred to reserves

The company is dependent for its working capital on funds provided to it by Folkestone Harbour Holdings Limited, the company's ultimate parent. Folkestone Harbour Holdings Limited has indicated that for at least 12 months from the date of approval of these financial statements, it will continue to make available such funds as are needed by the company and in particular will not seek repayment of the amounts currently made available. The director considers that this should enable the company to continue in operational existence for the foreseeable future by meeting its liabilities as they fall due for payment. As with any company placing reliance on other group entities for financial support, the director acknowledges that there can be no certainty that this support will continue although, at the date of approval of these financial statements, he has no reason to believe that it will not do so
