2.2 this authority replaces all subsisting authorities previously granted to the Sole

Director for the purposes of section 561, which, to the extent unused at the date

of this Resolution, are revoked with immediate effect, without prejudice to any

allotment of shares or grant of rights already made, offered or agreed to be

made under such authorities.
