**Security Accession Deed**

**THIS SECURITY ACCESSION DEED** is made on 21 October 2022

**BETWEEN:**

- (1) DD Group Holdings Limited (a company incorporated in England and Wales with registered number 07905936);
- (2) Mi-Tec Limited (a company incorporated in England and Wales with registered number 03582852);
- (3) DD Products and Services Limited (a company incorporated in England and Wales with registered number 01196676);
- (4) Med-FX Limited (a company incorporated in England and Wales with registered number 05693661);
- (5) Mintek UK Limited (a company incorporated in England and Wales with registered number 04771286);
- (6) TAG Medical Limited (a company incorporated in England and Wales with registered number 06116357);
- (7) Unodent Limited (a company incorporated in England and Wales with registered number 06048853);
- (8) BF Mulholland Limited (a company incorporated in Northern Ireland with registered number NI610167),  
(each a “**New Chargor**” and together, the “**New Chargors**”)
- (9) Phey Bidco Limited (a company incorporated in England and Wales with registered number 14124587) (the “**Company**”);  
and  
Alter Domus Trustees (UK) Limited as security trustee for itself and the other Secured Parties (the “**Security Agent**”).

**RECITAL:**

This deed is supplemental to a debenture dated 1 August 2022 between Phey Bidco Limited and the Security Agent, as previously supplemented and amended by earlier Security Accession Deeds (if any) (the “**Debenture**”).

**NOW THIS DEED WITNESSES** as follows:

**1. INTERPRETATION****1.1 Definitions**

Terms defined in the Debenture have the same meaning when used in this deed.

**2. Construction**

Clause 1.2 (*Construction*) of the Debenture will be deemed to be set out in full in this deed, but as if references in that clause to the Debenture were references to this deed.

**3. ACCESSION OF THE NEW CHARGORS****3.1 Accession**

Each New Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as a Chargor.

**3.2 Covenant to Pay**

Subject to any limits on its liability specifically recorded in the Finance Documents each New Chargor as primary obligor covenants with the Security Agent (for the benefit of itself and the other Secured Parties) that it will pay on demand the Secured Obligations when they fall due for payment.

**3.3 Fixed Charges**

Each New Chargor, as security for the payment and discharge of the Secured Obligations, charges in favour of the Security Agent with full title guarantee all of its right, title and interest in the following assets, both present and future, from time to time owned by it or in which it has an interest and, in each case, all Related Rights:

- (a) by way of first legal mortgage, all Material Property (including as specified in Schedule 2 (Property)); and
- (b) by way of first fixed charge:
  - (i) all other interests (not effectively charged under clause 3.3(a)) in any Material Property;
  - (ii) all Subsidiary Shares (including as specified in Schedule 3 (*Subsidiary Shares*));
  - (iii) all Investments (other than the Subsidiary Shares);
  - (iv) all Equipment excluding Equipment that requires labelling, segregation or periodic listing or periodic specification;
  - (v) all Intellectual Property (including as specified in Schedule 6 (*Intellectual Property*));
  - (vi) its goodwill and uncalled capital;
  - (vii) to the extent not effectively assigned by clause 3.4 (*Security Assignment*):
    - (A) the Assigned Agreements;
    - (B) the Insurances; and
    - (C) the Hedging Agreements,

other than any assets which are for the time being part of each New Chargor's stock-in-trade or work-in-progress.

**3.4 Security Assignment**

As further security for the payment and discharge of the Secured Obligations, each New Chargor assigns absolutely with full title guarantee in favour of the Security Agent all its right, title and interest in the following assets, both present and future, and in each case, all Related Rights:

- (a) the Assigned Agreements (including the Intra-Group Loans specified in Schedule 9 (*Intra-Group Loans*));
- (b) the Insurances (including as specified in Schedule 8 (*Insurance Policies*)); and
- (c) the Hedging Agreements,

provided that on payment or discharge in full of the Secured Obligations the Security Agent will at the request and cost of any New Chargor re-assign the relevant rights, title and interest in the assigned assets to that New Chargor (or as it shall direct).

**3.5 Fixed Security**

Clause 3.3 (*Fixed Charges*) and clause 3.4 (*Security Assignment*) shall be construed as creating a separate and distinct mortgage, fixed charge or security assignment over each relevant asset within any particular class of assets specified in this deed. Any failure to create effective fixed security (for whatever reason) over an asset shall not affect the fixed nature of the security on any other asset, whether within the same class of assets or not.

**3.6 Floating Charge**

As further security for the payment and discharge of the Secured Obligations, each New Chargor charges with full title guarantee in favour of the Security Agent by way of first floating charge all its assets, both present and future, not effectively charged by way of first fixed charge under clause 3.3 (*Fixed Charges*) or assigned under clause 3.4 (*Security Assignment*) and, in each case, all Related Rights.

**3.7 Notice of Intra-Group Loans**

This Deed constitutes notice in writing to each New Chargor and the Company of any charge or assignment hereunder of any Intra-Group Loans owed by that New Chargor or the Company to any other New Chargor or the Company. Each New Chargor and the Company, by execution of this Deed acknowledges the notice given by any other New Chargor to it pursuant to this clause 3.7.

**3.8 Land Registry Filings**

For the purposes of panel 8 of each Form RX1 that may be required to be completed by the Security Agent in relation to any Charged Property registered or required to be registered at HM Land Registry, each New Chargor consents to an application being made by the Security Agent to the Chief Land Registrar to enter the following restriction in Form P against that New Chargor's title to such Charged Property:

“No disposition of the registered estate by the proprietor of the registered estate is to be registered without written consent signed by proprietor for the time being of the charge dated [ ] in favour of Alter Domus Trustees (UK) Limited referred to in the charges register”.

**4. INCORPORATION INTO DEBENTURE**

The Debenture and this deed shall be read together as one instrument on the basis that references in the Debenture to “this deed” will be deemed to include this deed.

**5. NOTICES**

Each New Chargor confirms that its address details for notices in relation to clause 21 (*Notices*) of the Debenture are as set out immediately after its name on the execution pages of this deed.

**6. LAW**

This deed and any dispute, controversy, proceedings or claims of whatever nature arising out of or in any way relating to this deed (including any non-contractual disputes or claims) shall be governed by, and construed in accordance with, English law.
