

## Accounting policies

#### **Basis of accounting**

The financial statements have been prepared under the historical cost convention, and in accordance with applicable UK accounting standards

The directors have prepared these financial statements under the going concern assumption. The company directors have reviewed forecasts and are confident that the company will be profitable in the future. The company have the ongoing financial support of the ultimate parent company, Retail Merchant Group Limited, and have been assurred that it will continue to make sufficient funds available to enable the company to meet its obligations as they fall due.

#### **Cash flow statement**

The directors have taken advantage of the exemption in Financial Reporting Standard No 1 (Revised 1996) from including a cash flow statement in the financial statements on the grounds that the company is small

#### **Turnover**

The turnover shown in the profit and loss account represents amounts invoiced during the period exclusive of VAT Turnover is recognised when services are delivered

#### **Operating lease agreements**

Rentals applicable to operating leases where substantially all of the benefits and risk of ownership remain with the lessor are charged against profits on a straight line bases over the period of the lease

#### **Retirement benefits**

#### Defined contribution pension scheme

The pension cost charged against operating profits is the contribution payable to the scheme in respect of the accounting period

#### **Deferred taxation**

Deferred tax balances are recognised in respect of all timing differences that have originated but not reversed by the balance sheet date except that the recognition of deferred tax assets is limited to the extent that the company anticipates to make sufficient taxable profits in the future to absorb the reversal of the underlying timing differences
