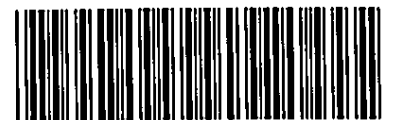



#### Notes
