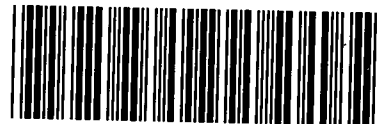

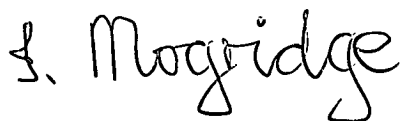
For the year ending 28/02/2014 the company was entitled to exemption from audit under Section 477 of the Companies Act 2006 relating to small companies.
