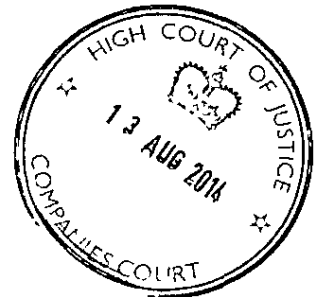

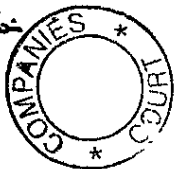

- (5) the hearing fixed for the 5th September 2014 be vacated


