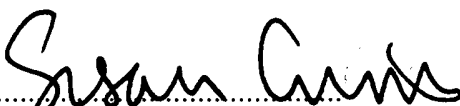
For the year ended 30th June 2016 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

1. Accounting Policies

i) Accounting Convention -
