
**DIRECTORS**

**RESPONSIBILITY**

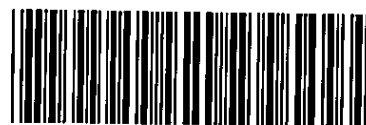

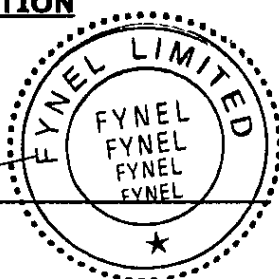

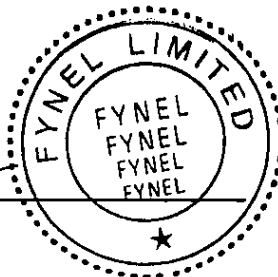
