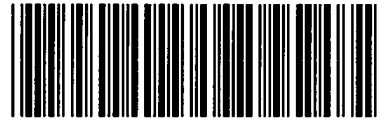



1. Accounting Policies

1.1 Basis of preparation of financial statements
