Turnover

Turnover represents net invoiced sales of services, excluding value added tax

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life

Short leasehold - Nil Improvements to property - Nil

Equipment - 25% on reducing balance Fixtures and fittings - 25% on reducing balance

Computer equipment - 33% on cost
